*The time is now and now is when God asked Suzzan and me to bring forward information concerning the plan for the synthesis of humanity.*

*(Synthesis is defined as the combining of separate elements or substances to form a coherent whole.) Now is the fullness of time, and each of us has an obligation to our evolving existence to come together with all matter for the good of the whole. There is no one coming to save us; all the messengers were there to teach us, and now we must use what we have learned for the impending events of our time.*

*In the symphony of the Cosmos, we are now being asked to follow the Conductor's lead, as harmony and rhythm are crucial elements to the discerning ear of time. We must become the instrument our higher self uses, which will sound the notes at the last trump. We*

*know the melody but were never before asked to play it. Not to worry, we are all given inherent sheet music. All that remains is our physical transmutation through undying devotion to the Maestro and the music. The universal oneness of all things, NO THING, composed the inherent sheet music and inspired that which steps forward to lead the orchestra ... **INTERESTED IN PERFORMING?***

*With the help of the Maestro, Suzzan and I have devoted the past twenty-two years to quieting the discord in our song of life on this plane of existence. In order to hear that still small voice within, it is important to have harmony in one's life, which extends to the inner peace of living. It is through such living that everyone will find his or her place in the orchestra, if he or she so desires. This cannot be taught, only sought in truth and experienced through living by the guided direction of inner knowing, with confirmations from NO THING and similarity of experiences communicated in communion with others.*



*Metaphors are wonderful aids when attempting to describe that, which can only be sensed and hoped for, not clearly understood and proven. Metamorphosing NO THING "God" into a being having human characteristics and emotions is a serious error, yet we do it without even thinking or through force of speech in the form of a pronoun, such as "he" or "she". Along with such a process comes the probability of false certainty in understanding the association with a thing and not a dynamic experience. Furthermore, in giving it a name we tend to imagine that thing outside ourselves as separate from us. Without a name or verbal identifier, it is most difficult to refer to anything in speech, as was exemplified when the entertainer Prince changed from using his name to using a symbol instead. The point is we are rather stuck with the process and hopefully we can appreciate: "What's in a name?"*

*Unfortunately the names God, and Christ (not Jesus' last name), as well as some others, have undergone the process that was just described, and many people today suffer misunderstanding because of it. Many words associated with the Christian Religion actually invoke a*

*mental gag, or shutdown response when used in communication with an idea or thought. The words that we speak of have been incorrectly or over used to such a degree that many people no longer want to hear them. This is most disturbing because the divinely inspired writings and teachings were given to help us identify and participate in the evolutionary chain of events so rapidly now taking place.*

*The symphony is the plan of God (NO THING) moving humanity in concert to perform the evolutionary jump occurring within the lifetime of most of us living. The Conductor is the Demiurge (Creator of the universe) working from the plan in unison with the mechanics of the universe defining the nature and structure of the jump. We are the rhythm of notes forming the melodious body of music to the harmony of God's plan. This melodious body of music referred to is the body of Christ, not just Christians per say, but anyone who wants to be an instrument. The energy and harmony of this body of humanity must be perfect and moving as one for the defining moment of synchronization (last trump) with the transformation and jump to a new*

*plane of evolutionary existence. Most of us have incarnated at this time to participate in the process. Please, take a serious moment to decide whether you will honor or fear your commitment to just such an endeavor.*

**The Good News: Reverberation** is a missive that is intended to activate a remembering and initiate break down of embodied walls of misunderstanding about Divinity in respect to life on this planet. The reader is urged to let the words reside with them in a manner that points the way to truth in the most personal of instances, the way to the depths of NO THING.

*There is good news in that there is a Divine Plan in place, which any and all of us may tap into if we so desire. This plan works hand-in-hand with the mechanics of the universe and evolution. The story of Jesus was given to us as a preview of coming events and a reference point for understanding this plane of existence and Spiritual Workings. The concept is simple if we accept that we are nothing more or less than Divinity's interface with this material plane. As a*

*spiritual being in symbiotic relationship with a human body, our primary function at this time is to choose whether to follow the plan.*

*“In the early 80’s on a lonely German backroad, like so many people who find themselves in a vulnerable position, I made a deal with God. As the subcompact car rolled over, his head struck the roof and, while sustaining his full body weight, the metal buckled into his scalp resounding with the sickening sound of vertebrae compressing in my neck. Upright again, trapped and unable to feel my legs, I realized I was really hurt. It was then I petitioned God, ‘If you get me out of this, I will dedicate my life to you.’ More than a decade later I made good my part of the supplication, manifesting the real power in those words.”*

In November 1993, I stood in a psychiatrist’s office in Jeddah, Saudi Arabia, and murmured the words: “Something momentous is going to happen to me I have something important to do.” It was the first inkling that I may have a manifest destiny. For my part, I did not have a clue what my statement in that office meant,

or where it would lead. Now, over two decades later, after many “adventures” and endless hours of study Craig and I both have a clearer understanding of our mission.

### Important Note:

Some of you, who have read *THE GOOD NEWS: An Alternate Theory* released in 2006 might be wondering why we have changed the title to *The GOOD NEWS Reverberation*. Our reason for doing so is multifaceted.

Upon first receiving the information through inspiration between 2003 and 2004, my understanding of the teachings was very new, consequently, my ability to fully explain what I was receiving, was also limited. Now in 2016, with my work on the *Know Thyself Initiative* on our website, my inspiration is much clearer, therefore, one of the reasons was to try to make my reasoning easier to follow.

Another reason was to incorporate new inspiration to help clarify the information and to correct a serious misunderstanding regarding the role of extraterrestrials in our history. I explain the specifics for my change in understanding in an update.

However, the primary reason was to share the really “Good News” that everything has changed.

## **:- THE BEGINNING -:**

A crucial moment in our studies for Craig and I came when we read the Gnostic teachings and embraced the existence of multiple layers within the Spirit and Soul planes. Historians report the early Church called the Gnostics heretics. (Note: the official Church was Catholic, meaning universal. It was also known as Orthodox, meaning straight thinking. At this time, there was no distinction between the two designations.) However, it surprised Craig and me to learn that many scholars believe that some Gnostic sects predate the official Catholic/Orthodox Church. This would make the formation of these sects closest to the time Jesus walked the earth.

Until fairly recently, the only source historians had for the Gnostics were the Catholic church fathers, known as heresiologists writing to contest the Gnostic teachers of the second century. I say until recently, because in 1945, near Nag Hammadi, Upper Egypt, a local villager stumbled over a collection of Gnostic texts. As many of these texts contained teachings that the second century

heresiologists contested, the investigators knew they were genuine Gnostic writings from the second century sect led by Valentinus. In reading, the interpretation of experts on ancient texts, Craig and I uncovered a very different understanding of the New Testament characters.

Reviewing the new information regarding the Gnostics, Craig and I saw a connection to something else God had led us to discover. How the Old Testament was multifaceted, with one layer possibly being a historical record of several major cataclysms. Still, for us the most amazing discovery was the reason for the infamous Fall, of the Human Race. All of these discoveries are dealt with in our books *LOVE The Common Denominator* (LCD) and *Our Story 1995 - 2002: True Philosophers' Stone*. (TPS)

Returning to the main message of this book, another meaning for Good News is the Gospel or New Testament. Therefore, with this premise what Craig and I wish to do is offer an alternate hypothesis for interpreting and understanding the New Testament and



the part some main characters played in Humanity's evolution.

The Gospels of Mark and John begin with the Holy Spirit entering Jesus at his baptism. Likewise, we feel that it is appropriate to start at the beginning, but is that the real beginning of the story. Gnostic teachers would answer with an emphatic No! They would tell us the beginning of Christ's entry into this realm began with the fall of Sophia/Wisdom (hereinafter referred to as Sophia). She was the feminine side of the last pair of emanations in the Gnostic Pleroma. At this point, it may be beneficial to relate what God told us about the Divine realm:

"It is impossible for the human brain to comprehend how spiritual forces operate. We can only identify with spiritual operation by relating to concepts we do comprehend."

In fact, it was not until the recent discovery of quantum physics that we began to understand energy, atoms and chemical forces. When the Gnostic teacher Valentinus

wrote *The Gospel of Truth*, about nineteen hundred years ago, Humanity did not even understand electricity, let alone atomic and sub-atomic particles. Consequently, the Gnostics tried to use terms that their contemporaries could understand. These analogies in no way meant that they saw the Divine realm in the same way as the mythical demigods whom the Greeks thought resided on Mount Olympus. Additionally we need to state that although we refer to God in "masculine" terms, this does not mean that we think of the Supreme Being as masculine. With this said, let us share what we came to understand about Gnostic emanations.

Words are insufficient to express how grateful Craig and I are to Professor Elaine Pagels. Her translation and explanation of the teachings of the Gnostic Valentinians brought them into a cohesive understanding. Apparently, the followers of Valentinus, who according to one report nearly became pope before his separation from Catholicism or orthodoxy, told a mythical story to explain the beginning of everything. Before relating the "myth", I must share what God told me concerning why

the teaching was in the form of a myth. Evidently, "A myth is a way to describe an absolute truth in an abstract way."

The Gnostic myth concerned the formation of the highest Spiritual Plane, before anything else existed. Valentinus taught that everything began because desiring to be known, the First Father or Supreme Being, projected Himself into His consort, Silence, which brought forth two emanations, Mind (masculine) and Truth (feminine). This pair in turn brought forth the Logos (masculine) and Life (feminine), who brought forth the pair Humanity (masculine) and Church (feminine). (It is important to keep in mind these are ancient terms translated into English and we should not confuse them with the definitions of the words church and humanity used today.) These six emanations, together with Silence and the Supreme Being, made up what the Valentinians referred to as the Ogdoad (8). The pair Humanity and Church also brought forth a pair who subsequently emanated another pair.

Eventually, apart from the 8 Ogdoad members there were eleven more pairs, (22) which completed the thirty members of the Divine realm. The Gnostics called this realm, the Pleroma, where each pair consisting of both masculine and feminine aspects worked together in unison.

As stated, the human mind can only conceptualize Divine powers in the vaguest terms. This is why Jesus taught in parables and allegories; our vocabulary is wholly inadequate. Consequently, to attempt to put the pairs of emanations into our frame of reference is extremely difficult. Even so, God explained to us that rather than seeing these pairs in terms of couples, we should regard them as pairs of opposites, such as active and passive or positive and negative.

Regrettably, as Craig says, "Today we connect the word 'negative' to anything evil, but here we need to see negative as analogous to, relatively speaking, the negative prong of an electrical appliance's plug working in conjunction with the positive prong. For an appliance to operate, we need both the positive and negative

prongs. Another example of how Divine potencies work together is the bee (active) pollinating the flower (passive); both depends upon each other."

Valentinus told his followers the reason for creation, began with Sophia, the feminine side of the last pair of emanations. It seems, she went in search of her origin without her partner, (What-has-been-willed). Learning Sophia or Wisdom's partner's designation, Craig and I wondered if we could view him as the Divine Will. As he was from the "Divine" realm, we understand that it is an appropriate "alias."

Due to Sophia acting without her masculine/active partner, What-has-been-willed, she went against the natural order. In seeking the Supreme Being, she turned back and, in the words of Valentinus, "Was in danger of being absorbed into the Father's sweetness." We understood this to mean that when Sophia beheld the magnificence of the Supreme Being, she became mesmerized and moved to rejoin Him. This is akin to a moth flying too close to the flame. As fire absorbs or destroys a moth, Sophia was in danger of annihilation.

However, unlike the exposed flame, a power or in the modern vernacular a force field, which the Gnostics refer to as the Limit, surrounds the Supreme Being. The difference between this force field and others was the Gnostic Limit had consciousness, and was capable of supporting and restoring Sophia to her rightful place within the Pleroma.

Unfortunately, the emotions Sophia experienced in her encounter could not be absorbed into the Pleroma. Accordingly, the Limit expelled them from the Divine plane, causing Sophia to become separated from parts of her. To use an analogy, this would be similar to the amputation of a person's gangrenous arm or leg.

Since Sophia was a member of the Pleroma, she was entirely infused with Divine power from the Supreme Being, or First Father. Therefore, her rejected emotions were also divine. In fact, we could see them as divine sparks.

To avoid Sophia's contamination spreading to the rest of the Pleroma, for want of a better description, the

Limit temporarily placed a Veil between the Divine realm and that portion of Sophia, which was expelled, in effect, starting a new realm of existence that we know as the Ether, Astral, or Soul Plane. In addition, to prevent it happening again, the Supreme Being emanated the Christ, along with His partner the Holy Spirit, to teach the members of the Pleroma of their progenitor.

Humanity has retained the memory of the union between the emanations in the Pleroma through the myths and legends of creator gods and goddesses. We know these deities by different names throughout the world, such as, Shakti and Shiva, El and Astarte or Ashteroth, Baal and Baalti, and Zeus and Hera. Gradually the populations divided these pairs into sun/sky-gods and earth-goddesses. Civilizations using brute force to rule and conquer their neighbors, gravitated toward the veneration of "sun/sky-gods," whose power they saw reflected in eclipses and thunderbolts. Tribal communities relying on their survival by cooperating with "Mother Nature" came to venerate the feminine side of deity through the

goddess. Regardless of later civilizations having given predominance to the male gods, the ancients always saw creative forces as dual. The concept of rulers as king and queen and emperor and empress, also reflected the union of the members of the Pleroma.

Writing of the "birth" of Divine powers puts the process in some kind of sequential order. We live in a linear universe; however, the experience of linear time is only possible on the Physical Plane. Within or above, there is no past, present or future. There is only NOW. Consequently, the Supreme Being emanating the Christ and the Holy Spirit would have happened simultaneously with the other emanations, not to mention, Sophia's mistake.

As the Supreme Being emanated the Christ and the Holy Spirit, they were superior, so to speak, in respect to the other members of the Pleroma. In fact, this is where the concept of the Trinity makes entry. However, it is not the traditional definition given by the Church. In the Gnostic trinity, we have the Father (Supreme Being), the Son (the Christ), and the daughter (the Holy



Spirit.) For most people, “Only-begotten” as a designation is unique to the Christ, which causes great confusion over the person of Jesus. Many interpret this designation as not born from God, but a part of God. God had told us the key to the mysteries is hidden in our language (English). We can apply this key to help us understand the difference between the Christ and Holy Spirit and the other members of the Pleroma. To recap:, the members of the Ogdoad had resulted through the First Father/Supreme Being’s “projecting” Himself into His Consort, Silence. If we remember that a projector is used to “project” images onto a screen, we can see the difference. The word “emanates” means to bring forth from the source. In other words, the Christ and Holy Spirit, rather than being a projection or “image” of the Supreme Being, were of His substance. Despite the Church making the Holy Spirit masculine, as the partner of the Christ, she was feminine. Hence, we could think of the Holy Spirit as the “only begotten” daughter of the Supreme Being.

All of the above is very difficult to understand from a contemporary frame of reference. However, God

communicated to us if instead of names such as Mind, Life, Humanity and Limit, we think in terms of frequencies as in light, sound, vibration, and molecular bonds, then it takes on new meaning, even becoming closer to today's scientific view. Later, I will return to this concept.

Desiring to rescue or recover her lost aspects, Sophia united with the Christ. Leaving his partner the Holy Spirit in the Pleroma, He left to help Sophia rescue the divine sparks. Ptolemy, a successor to Valentinus taught that Sophia and the Christ transformed her fear into water, her grief into air, and her ignorance into fire (we should see ignorance here as anger or frustration and not uneducated). You may have noticed that I only list three elements. This is because at the time, people only knew of three elements. However, God told me that Sophia also experienced confusion, which became the element earth, completing the four main elements.

Even though I have been speaking of Sophia in feminine terms, we should not see "her" as a goddess. Craig and I understand from God that Humanity is

destined to unite the opposites: darkness and light, male and female, and spirit and matter. Therefore, to think of the Gnostic emanations in terms of male and female gods and goddesses could be an error. Rather, it would be more appropriate to think of them as androgynous. Interestingly, the Greek term for spirit is *pneuma*, which is neuter, neither masculine nor feminine, but both.

The elements of the universe made from Sophia's Divine residue (emotions) became the divine sparks or spirit within the Life Principle. These sparks, lying dormant were awaiting an awakening. Of course, to awake the sparks required the interminable cycles of evolution, with the goal being to transmute the four elements made from the rejected emotions of Sophia back into Spirit and release the divine sparks.

Due to the elements containing Sophia's essence, they were of a dual nature, spiritual and material. They also contained both intelligence from *Nous* or Mind and the energy of life from Life. Gnostic teachings report that to redeem her residue, Sophia and Christ brought forth

the Demiurge, or as we know Him, the Creator and God of the Old Testament, worshiped throughout the world under various names. Because the Creator/Demiurge was beneath the Veil, the creation of a new realm, known as the Soul realm came into being. This realm encompassing multiple layers including the Astral Plane caused every being beneath the Veil to become ensouled.

Gnostics believe the Creator remained ignorant of his true origins, namely, originating from the Christ and Sophia. Proof of this for the Gnostics is in His statement in the Old Testament, "I am a jealous God..." Alternatively, Valentinus points out how Jesus taught that the Supreme Being or Heavenly Father was LOVE. One of our first directives was that our mission involved vindicating "Jehovah". In my childhood, I knew Jehovah was the Creator, but I now understand the name is the English translation of the Hebrew Yahweh. Wondering, how we could take on such a task, we now understand that we were to remove all violent acts from the Creator's responsibility: more on this later.

The Demiurge/Creator's role was as the Architect of the universe to administer evolution. He was unaware of the divine sparks lying dormant in the elements, and so with the statement "Let there be Light" he unwittingly began the awakening of those sparks.

Obviously, the "Light" referred to in Genesis is not daylight or sunlight as this statement occurs before the creation of the sun and moon or stars. Craig and I think we should see the "Light" in Genesis in terms of Electricity. For instance, when we switch on the light in a darkened room, we see the contents. In other words through the senses we become aware of the contents of the room. Even a blind person uses his or her senses of touch, smell, and hearing to determine their surroundings. Consequently, if we connect Light with the enlivening of the Life Principle encased within the elements, then we can also associate the Big Bang with this event. One could also consider this instant as the beginning of the objective plane and linear time.

It may also help to think of the divine sparks, dormant within the elements in terms of the sparks that fly off

from a bonfire. They have no volition of their own and are completely at the “mercy” of the wind. Here, the bonfire represents the Supreme Being and the sparks that fly off into the night are the divine sparks in the elements.

Since the sparks immersed in the elements came from above the Veil in the Pleroma, not only were they alive, but they also had the capacity to co-create. All they waited for was the development of the intellect, which occurred with the development of *Homo Sapiens, sapiens*, our species. Our development enabled the Life Principle’s access to Mind/Nous and therefore an intellect.

Earlier I discussed how the Human Race had retained the knowledge of the masculine and feminine powers by the worshipping of male and female “gods and goddesses.” In the list of deities, I did not include Osiris and Isis because they were actual historical figures and the first incarnations of the Christ and Sophia, respectively.

In the book *LOVE The Common Denominator*, I included Osiris in the Christ-like teachers. I also demonstrated that according to historical scholars, the rituals and rites of Isis were adapted into Mariolatry, or the worship of Mary the mother of Jesus. Furthermore, through our studying Craig and I discovered the ancients saw Isis as not only Osiris' wife, but also his sister. Abraham and Sarah's relationship reflects this, which is probably why in many ancient civilizations the rulers were often brother and sister.

There was a legend that Isis with her consort; Osiris corrected the "watchers mistake" with Humanity. (The ancient *Book of Enoch*, translated by Richard Laurence, relates that these "watchers" reveal the mysteries to humankind, which results in the multiplying of evil.) The watcher's mistake has two components. However, our interest is that it was the reason the Christ and Sophia took on corporeal form.





## **:- THE AWAKENING -:**

Our Solar system became the chosen arena for the recovery of the divine sparks. This was because although life developed throughout the universe, only the elements of our Solar System contained the sparks, or residue of Sophia. In thinking about this statement, I wondered how this could be. If all Life on Earth contains the sparks, then how can it be that non-earthly "living" beings do not. God's answer was that the rest of the Cosmic Cultures are not of the same elements.

I knew from science class all life on earth is carbon-based, so was I to take it that extraterrestrials are not carbon-based? Some investigators of the UFO issue speculate that they are silicon life forms and represent the next stage in our evolution. This made sense to me, but God told me that it involved our position in evolution. However, I will leave the discussion on our role in evolution until later. For now, I want to discuss the Christ and Sophia's plan to redeem her lost parts, which through evolution immersed within the physical

vehicles, the divine sparks became the spirit within all life, both incarnate and disincarnate.

As stated, in order for the sparks to gain understanding, the Life principle had to develop intellect. Esoteric teaching reports that the Life principle moves through the mineral, vegetable, and animal kingdoms, before becoming human.

All Life is conscious, but not all living/conscious beings are capable of rational thought. Let us briefly examine each category. Most people think of the mineral kingdom as inert matter, but minerals such as crystals grow and do not remain stagnant. Then is the fact that healers use crystal energy in their healing practices. Does this mean that minerals are alive? The first category that many scientists acknowledge as sentient or living is the plant kingdom. Plants are conscious and some people believe that plants can feel pain. Included in the next category are insects. Colonies of ants and bees do not live individual lives but rather instinctually act for the good of the hive/hill/nest. Initially, we see the animal kingdom, such as packs of wolves, hyenas

and wild dogs, and herds of antelopes, zebra and wildebeests instinctually repeating this behavior. Nevertheless, the goal of evolution is to drive the Life Principle to individuality. The first sign of this is the appearance of family/blood groups and continues to develop in the animal kingdom through species like the big cats, such as tigers and leopards. We see the highest example of sentient individualism in animals with the domesticated dogs and cats. As our pets, the consciousness of these animals is the closest to exhibiting human behavior.

Nevertheless, the ultimate individualism came when the Life principle evolved into the Human Race. This is when evolution took a huge leap. The allegory of Adam and Eve becoming aware that they were naked symbolized this. Moreover, the imbibing of the fruit of the tree of knowledge of good and evil, apart from relating to the Life principle gaining intellect, as well as the ability to discern right from wrong, also demonstrates the ability of self or individual awareness. What Craig and I were surprised to learn recently was that the Divine forces

above the Veil were waiting, so to speak, for the development of the Life principle into human beings.

Beneath the Veil, the Life principle slowly developed souls as vehicles for the divine sparks. Each soul was the instrument the Life principle used to evolve; however, it was only with the advent of the individual human being that the soul could come into play. When the Life principle developed intellect, it could then begin the process of spiritualizing the elements through transmuting human emotions, to return the sparks or residue of Sophia to Spirit.

Genesis chapter one reports the creation of the Human Race. Verse 27 has, "...male and female created he them." This would appear to mean that not only the creation of human beings had occurred before Adam and Eve, but also like the Divine emanations, they were androgynous. So what does the story of Adam and Eve mean? Craig and I believe one of the multiple meanings is relating the separation of the sexes. The allegory of Eve's creation from a rib of Adam is a metaphor for this.

Interestingly the name Eve in Hebrew means Life. Remembering that Life's partner was the Logos and that they were members of the Ogdoad, was the writer of Genesis trying to impart yet more secret information by calling "the first woman" Eve? Some people have interpreted the name of Adam to mean the element earth. Tradition has that Eve came from a rib of Adam, but curiously, Craig and I learned recently that one school of thought replaces the rib with the heart.

Life is in a manner of speaking the ancestor of Sophia. Therefore, as Sophia's emotions became the elements of the universe, could one of the meanings of the allegory of Eve coming from Adam be that the Spirit of Wisdom, Life is within matter. Since the Life principle developed a soul, the divine sparks became connected to the Soul Plane, with the Spirit encased within the vehicle of the soul. While in this temporary vehicle, the divine spark or Spirit's role was through intellect, to understand the Truth that the individual Spirit's destiny is to reunite with the All, the Supreme Being.

Although, many see the makeup of humankind in modern terms as variously, Mind, Body, and Soul, Mind, Body, and Spirit, or Spirit, Soul, and Body, the ancients saw the human being consisting of seven separate bodies. Esoteric teaching tells us that three of these seven bodies are souls, namely, animal, human, and spiritual. Is Genesis relating the insertion of the spiritual soul, when it records that after the Lord breathed Life into Adam he became a living soul? Again, obviously Life here cannot mean literal life, as it already existed. However, if we remember that Life was the partner of the Logos and these two were members of the first eight or Ogdoad, then we can see the possibility that the higher spiritual forces were acting through the Creator/Demiurge's "breath" to infuse humankind with the spiritual soul. In addition, is it a coincidence that Humanity is the only species on the planet to possess fully articulate speech? Considering that Life's partner is the Logos, which is also known as the Word, is it surprising that humankind developed the ability to converse with one another? It is by the secret oral teachings handed down through the generations that the Truth has survived. Nonetheless, like many gifts,

they are double-edged swords. The ability to speak allows for the communication of the Truth throughout the ages. Conversely, because we are co-creators, humanity's words have power and depending on the intent can be either benevolent as in prayers and blessings or malevolent as in curses and condemnations.

With evolution, everything was progressing according to plan until the unforeseen event occurred, universally known as the "watchers mistake." However, as I said, this was a two-part event, but more importantly, it involves a serious misconception on my part.

In the *Book of Enoch*, the "watcher's mistake" is attributed to the "watchers" revealing the mysteries to human beings. Even so, what I did not realize is that there were two categories of watchers, angels and extraterrestrials. Initially, understanding that it leads to Humanity's "Fall", using logic I attributed it to the later. Nonetheless, as I wrote in *FOR THE CHILDREN*, Craig and I have since reconsidered our position. In the book,

I present all the evidence that led us to a new understanding.

For quite some time we interpreted the *Watcher's Mistake* as being responsible for the proverbial *Fall*, but knowledge is dynamic. Therefore, as we evolve and are able to assimilate deeper understandings our interpretation often changes. In Craig's and my case, there were two main reasons for reevaluating our conclusions, our discussions with Carol and working with our friend and associate, Dr. Carl Johan Calleman. Having come to know, respect, and work closely with Carol, we discussed our views on the role extraterrestrials have played in history in particular the theory of their role in the *Fall*. With her absolute conviction that the *cosmic cultures* did not cause the *Fall*, we began to wonder about our conclusions.

Throughout our journey, we have found it is essential to pay attention to everything. Often through a new friend like Carol's perspective, or new information emerging we have made the greatest breakthroughs. Our recent questioning of our interpretation of the *Watcher's Mistake* is a perfect example of the need to remain not only open, but also attentive.

Especially evident in Dr. Calleman's latest book Volume 1 of *The Paradigm Shift Trilogy: THE GLOBAL MIND AND THE RISE OF CIVILIZATION: A Novel Theory of Our Origins* is his conviction that the *cosmic cultures* did not affect our evolution. Consequently, he may come across as a little rigid in his conclusions on the role of extraterrestrials. In discussing this question with Carl, although acknowledging the existence of intelligent life in the universe, he believes we first need to evolve past separateness before thinking about connecting with the *cosmic cultures*. In fact, he told us that helping us to evolve is his goal in the book. As a scientist, he is more than aware how difficult it is to present a theory to the academic community. Egyptologists and archeologists require empirical evidence before even considering an alternative theory on our origins.



In his view, focusing on who built the Giza Pyramids gets in the way of examining the theory.

Amazingly, the book provides evidence of our connectivity through a unified field that Carl calls the Global Mind. The book also reveals evidence of our connection to the divine power within. Accordingly, it offers new solutions to the world's problems. Even though, we feel there is evidence of possible extraterrestrial visitation in the past. Carl's approach to that issue opens up an innovative discussion on human development that does not necessitate alien interference. As a result, it presents a different view on our origins for consideration. The book's value is that it scientifically explains so much about our likely history and reality. We will be discussing the importance of this brilliant book later, but for now let us move on to the other people who caused us to take another look on our conclusions of who caused the *Fall*.

Along with the aforementioned opinions on the role of the *cosmic cultures*, there was the book by Andrew Collins, *From the Ashes of Angels: The Forbidden Legacy of a Fallen Race*, which traces the legends of the *Watchers* to Kurdistan-Iraq. Finally, there was a recent presentation from Graham Hancock. Without doubt, all four sources appeared to be guiding us in a different direction. Obviously, it was time to take another look, which naturally meant going back to the beginning.

There were certain *pillars* we felt we could rely on. For instance, we knew that the purpose of Life was to individualize and become co-creators to transmute the elements back to spirit. In this Dr. Calleman's work with the Mayan Calendar was invaluable as he showed us how the calendar reveals that evolution has progressed in a sequence of Nine Waves up until the present. Another *pillar* was that Spiritual Evolution mirrored physical evolution through consciousness development in the form of *root-races* (term for different levels of human consciousness) developing into their roles as co-creators. We also knew that it was shortly after the 3<sup>rd</sup> *Root-race's* emergence in 41,040 B.C.E. that the *Watcher's Mistake* took place.

One of the strongest *pillars* we felt sure of was the ancient astronaut theory. Even with the recent documentary debunking a lot of

evidence presented on the History Channel's *Ancient Aliens*, to us there was still a great deal of evidence of the presence of advanced technology, a lot we cannot even repeat ourselves today. Moreover, there are so many myths and legends of *gods* giving the native inhabitants gifts of civilization, agriculture, and the like. All of this adds up to the high probability that ancient astronauts visited the earth long ago. With the sudden inexplicable *leap* recorded around 40,000 B.C.E., this date would appear to mark one such visit. Purely from a logical perspective, we felt scientists visiting from another world would naturally conduct experiments on the native species of earth, perhaps in an effort to eradicate disease. The reason I say this is that recently we found information on tablets indicating the ancient Sumerian *gods* were doctors trying to eradicate disease. Of course, the tablets are referring to the period in Sumer around 5,000 B.C.E, 35,000 years after the great leap of approximately 40,000 B.C.E. As this new information is so important, we will return to it later.

Obviously, visitors to Earth in 5,000 B.C.E. would find a completely different species of human being. To a highly advanced culture, archaic humans (40,000 B.C.E.) would have appeared as little more than animals to them. After all, books even depict them as cave dwellers. Perhaps they saw them in a similar way to how we view chimpanzees and gorillas. Nonetheless, something happened in 40,000 B.C.E. to cause these *cave dwellers* to become artists.

As the date 40,000 B.C.E. for the *Fall* seemed likely, we felt it was time to rethink our previous conclusions on its cause. So if possible interference of our ancestors, in whatever form was not the cause of the *Fall*, what could it be? A crucial point was that those responsible for the *Fall* were the so-called *Watchers*. We knew the *cosmic cultures* were *Watchers*, but so were the angelic realms of spiritual beings. If we removed the former from the equation, this only left the spiritual beings. This is where Andrew Collins' book *From the Ashes of Angels...* came in. The author believes he has found evidence of a lost ancient race of giants who evolved on earth. He posits these giants, known as the *Nephilim* were the offspring of the *Watchers*.

At first, we did not consider Collins' theory valid because we understood that the *Watchers* were not native to the earth. However,

when we remembered how the *Neanderthals* emerged and completely disappeared within less than 200,000 years, a blink of an eye in evolutionary terms we reconsidered his theory. Collins suggests that perhaps myths and legends was the way the ancients preserved the existence of a race of giants now lost to history. We have to admit his evidence is compelling.

Using ancient scriptures along with tribal traditions, Collins systematically lays out his theory of this lost race of giants. Interestingly, he also refers to them as *birdmen* and even *serpents*. Having already traced references of the proponents of the *Wisdom Religion* to men known as the *Serpents of Wisdom*, we could go along with his suggestion that when the legends refer to serpents, they may be speaking of wise men. Using local angel myths and legends, Collins shows the persistent thread of a race of giant *birdmen* (they were believed to be over 7-feet tall) living in the remote areas of Kurdistan-Iraq.

Nevertheless, Collins' main thrust in his book is that these *birdmen* and or *serpents* were responsible for ancient underground cities. Some of the most amazing evidence he puts forth are the underground cities in modern Anatolia, Turkey formerly known as *Cappadocia* in Asia Minor...

Asking why people would go to such great lengths to build cities underground, Andrew Collins relates that a local historian and archeologist by the name of Omer Demir had spent several years with archeological teams investigating *Derinkuyu*. He gives some extraordinary tidbits to cause us to scratch our heads from Demir's book: *Cappadocia – Cradle of History*. For instance, an underground city covering an area of "two and a half square miles" was undiscovered by locals until 1963. Furthermore, although eight levels have been explored this "eighth wonder of the world" according to Demir is known to have "between eighteen and twenty" levels.

Because there is no way to date stone, we cannot accurately determine when or who built the lowest and largest tunnels. Regardless, Collins is more interested in the reason for the colossal undertaking of creating a city underground. As he believes the lowest levels were built by the *birdmen-serpents* and or race of giants. His

reasoning is logical, because evidently these levels have the highest ceilings. In addition, he posits that these lower level *builders* survived into historical times. Citing the fact, the Bible records the antediluvian patriarchs lived a good deal longer than the *three-score-and-ten* (70) years later ascribed.

Supporting his argument Collins quotes multiple local legends and stories of supernatural events surrounding these *birdmen*. Could he be right? Are there ancient writings about this lost race living for hundreds of years? This question reminded us that the Bible is not the only ancient writing that speaks of huge life spans. In the chapter, *Rumors of gods* in LCD we related how the historian Herodotus recorded such life spans:

*Herodotus, 484 to 425 B.C.E., related that Egyptian priests at Thebes told him of the history of Egypt. Showing him 341 statues, they informed him each statue represented a generation covering, 11,340 years. "They (the priests of Zeus) brought me into a great hall and showed me the huge wooden figures—they say, before these men there were gods who were rulers of Egypt, who lived not at the same time as these men; and, of these gods, one was always supreme ruler. The last of these divine beings to rule Egypt was Horus, the son of Osiris, whom the Greeks call Apollo. They say, Apollo/Horus deposed Typhon and became the last god to rule Egypt. Osiris, in the Greek language, is Dionysus."*

In his book, Andrew Collins provides evidence for the origin of the *Watchers* or *birdmen* as Egypt. However, it is the Bible's greatest patriarch, Enoch that provides the real breakthrough, because it leads us to the greatest source we have for the mysterious *Watcher's Mistake*, *The Book of Enoch*. We originally addressed it in the same chapter as above in LCD:

*The Book of Enoch relates that angels taught the women sorcery and incantations, and that the results of the angels' unions with the women were giants. Apparently, the angels taught many things, including; "astrology," "astronomy," and "dividing of roots and trees..." The giants become the evil spirits because of the union of spiritual beings (angels) and earthly beings (women). Enoch then brings in a different*

*term, watchers. These “watchers” reveal the mysteries to mankind, which results in the multiplying of evil. Amazingly, he says that the “Tree of knowledge”, contrary to the Bible, does not bestow death. Instead, it bestows “great wisdom,” to anyone who eats of it.*

*...According to Enoch, humankind was destroyed because they knew every secret of the angels. He tells of prophecies that include the information that, the righteous in the seventh week will be given the sevenfold doctrine... An interesting fact is that many scholars believe Enoch could be Hermes. The name Enoch is generic and means initiator, or teacher. Esoterically, Enochian means, “The seer of the open eye...”*

There are four very important points that jumped out from the above extract that were not so obvious when I originally wrote it:

- 1) There seems to be more than one type of being interacting with the humans: angels and watchers.
- 2) It is the angels that “taught...dividing of roots and trees...”
- 3) These “watchers” reveal the *mysteries* to mankind, which results in the multiplying of evil
- 4) The “Tree of knowledge... bestows “great wisdom” to anyone who eats of it”

Through our investigations, we determined the *Watchers* tasked with observing the development of Life on this planet were both spiritual and cosmic beings. Consequently, if the *Watchers* who “reveal the mysteries” to humanity are not the cosmic beings, it has to be the spiritual beings, or angels who are responsible for the *Fall*. This would appear to be a correct assumption as Enoch equates the reason for the destruction to humanity knowing “every secret of the angels.”

We kept coming back to the teaching of “dividing of roots and trees” as being a problem. Obviously, we needed to return to the relevant passage in the *Book of Enoch*. Looking it up on the web and finding a site that published the entire book, we found the passage below:

And all the others together with them took unto themselves wives, and each chose for himself one, and they began to go in unto them and to defile themselves with them, and they taught them charms and enchantments, and the cutting of roots, and made them acquainted with plants.

Moved to dig deeper, we searched the *Book of Enoch* to see if it could shed more light on the matter. It did as it recorded which angel taught what:

Semjâzâ taught enchantments, and root-cuttings, Armârôs the resolving of enchantments, Barâqîjâl, taught astrology, Kôkabêl the constellations, Ezêqêêl the knowledge of the clouds, Araqiêl the signs of the earth, Shamsiêl the signs of the sun, and Sariêl the course of the moon."

What we found most interesting was that "enchantments" connects to "root-cuttings," because it brings in the emergence of magic...

*...Frances A Yates in her THE ROSICRUCIAN ENLIGHTENMENT relates that there are four kinds of magic. Quoting from Gabriel Naudé's work "Apology for Great Men Suspected of Magic", she explains, "...there are four kinds of magic..." Gabriel Naudé related that the four were "divine magic", "theurgy or religious magic" "goetia" and "natural magic." Divine Magic is self-explanatory, but I wasn't sure about the rest. Evidently, theurgy or religious magic, is "freeing the soul from the contamination of the body", Goetia magic is another name for "witchcraft." The final kind Natural magic, according to Naudé "...is natural science."*

*What our ancestors didn't realize is that the only form that was completely safe is divine. Two of the three other kinds "theurgy or religious" and "natural magic" are neutral, wholly dependent on the intent of the practitioner, i.e., when it is used for selfish motives, it is black magic and when it is selfless, it is white magic. Goetic magic is the most dangerous as Ms. Yates recounts Naudé's warning, "Goetic magic is witchcraft." In other words, this kind of magic is only used for nefarious means...*

By the time of the Roman Empire, magical practices were common among the general population. Consequently, it required drastic

measures to protect humanity from itself. That the leader of the angel *watcher's* was responsible for the corruption or *Fall* of Humanity is obvious by the *Book of Enoch* reporting of the angel's punishment. Curiously, the leader *Azâzêl* did not appear associated to any specific teaching:

*"The Lord said to Raphael: 'Bind Azâzêl hand and foot, and cast him into the darkness: and make an opening in the desert, which is in Dûdâêl (God's Kettle/Crucible/Cauldron), and cast him therein. And place upon him rough and jagged rocks, and cover him with darkness, and let him abide there forever, and cover his face that he may not see light. And on the day of the great judgement he shall be cast into the fire. And heal the earth which the angels have corrupted, and proclaim the healing of the earth, that they may heal the plague, and that all the children of men may not perish through all the secret things that the Watchers have disclosed and have taught their sons. And the whole earth has been corrupted through the works that were taught by Azâzêl: to him ascribe all sin."*

Genesis appears to ascribe the *Fall* to Adam and Eve imbibing of the fruit of the *Tree of Knowledge of Good and Evil*, but the *Book of Enoch* mentions nothing about the "tree," so what was the "forbidden fruit" that so corrupted the human race?

As we were finishing Andrew Collins book on his theory of the *Watchers* responsible for the *Fall*, our good friend Leyland sent us the latest presentation by Graham Hancock. As the author is famous for his interpretation of ancient buildings, we were intrigued to find this presentation concerned his discovery that the ancient Egyptians used psychotropic plants in sacred ceremonies.

Citing the evidence of certain mushrooms appearing within the hieroglyphs and ancient paintings, Hancock wondered why the Egyptians used them. As there are legends that the sarcophagus in the Great Pyramid was for initiations, he developed his theory. Namely that an initiate would take a hallucinogenic concoction before spending time (probably 3 days) lying in the empty king's chamber in an altered mind state. However, it was Hancock's connecting cave painting and the use of psychotropic mushrooms that we found most interesting. It captured our attention because in his new book, *THE*

*GLOBAL MIND AND THE RISE OF CIVILIZATION...* Dr. Calleman observes the relevance of cave art in the development of human consciousness. The latter, also points out that the Mayan Calendar records this development in evolution with Day 5 coinciding with 40,000 B.C.E., and the first appearance of cave art.

For Graham Hancock, the presence not only of *therianthropes* (a combination of animals and humans), but also mushrooms on cave walls indicates the “cave artists” were using psychotropic mushrooms to alter their consciousness. This statement caused us to remember that the *Fifth Wave*, which Dr. Calleman equates with the development of consciousness started during Day 4 of the *Fourth Wave* developing the size of the brain. To us this implies that the development of consciousness and the physical development of the brain occurred simultaneously. If so then this could be a clue to the cause of the *Fall*.

Removing ancient astronauts visiting our ancestors from the equation of causing the *Fall*, we have only beings from the spiritual realm as possible candidates. From the above sections of the *Book of Enoch*, this would appear to be a fair assumption. As such then, we can deduce that something they did triggered the *Fall*. Still, the *Fall* although referred to as the *Watcher's mistake* was no small thing. It resulted in the creation of the false self, not to mention expulsion from the Garden of Eden. As Genesis records, after Adam and Eve imbibe from the Tree of Knowledge of Good and Evil, “...the eyes of them both were opened, and they knew that they were naked...”

If we remember that the purpose for Life was to become individuals and transmute the elements back to spirit, we can see why this was such a serious infraction. However, it had nothing to do with eating an apple. Putting all the pieces together, we believe the *forbidden fruit* was the introduction of psychotropic plants to our early ancestors. Let us consider what affect mind-expanding drugs would have in a developing consciousness. As they were destined to be co-creators of our world, we can get a glimpse of the outcome. In meditating on this, we understood that it was akin to putting 5-year-olds (with new souls) in charge of the world. Even more problematic, in this scenario every adult is compelled to obey every child's whim. The truth was that the knowledge of “dividing roots” and “plants”



became accessible before our ancestors had evolved enough. This caused a fracturing of the psyche, resulting in the imbalance and separation of the masculine or active self-conscious and the feminine or passive subconscious. We see this reflected in the reference to Eve's creation facilitated by a rib taken from Adam. This imbalance has manifested in very harmful ways from that moment on.

Another consideration that has only recently come to light is that the *angel-watchers'* actions altered the brain waves of the native species. Without going into this too deeply here, before the *Fall* humans operated at the *Theta-wave level*, or 4-7 cycles per second. We recorded how this level equates to consciousness in *Our Story 1995 – 2002: True Philosophers' Stone* (TPS). It concerns an excerpt from Richard Alan and Iona Miller, in their article on “Schumann's Resonances and Human Psychobiology”

*“Schumann's resonance forms a natural feedback loop with the human mind/body...” The authors state that the “pulse” performs as a “driver of our brains” and has the possibility of transmitting data too. It seems that the natural development of the Human Race could be changed and “new patterns of behavior facilitated through the brain's web of inhibitory and excitatory feedback networks.”*

For those more familiar with the term *Schumann Resonance* as a scientific principle, Wikipedia describes it as “a standing wave in the Earth–ionosphere cavity with a wavelength equal to the circumference of the Earth. This lowest-frequency (and highest-intensity) mode of the Schumann resonance occurs at a frequency of approximately 7.83Hz.”

*Theta level occurs most often in sleep, but these waves are also dominant in the deepest state of meditation (body asleep/mind awake). The optimum level for deep thought is this realm of Theta. In Theta, the senses are withdrawn from the external world and focused on the mindscape, internally originating signals. Theta waves are associated with mystery, an elusive and extraordinary realm a person can explore... In theta, a person is in a waking dream, vivid imagery flashes before the mind's eye and they are receptive to information beyond their normal conscious awareness. Theta has also been identified as the gateway to*

*learning and memory and awakens intuition and other extrasensory perception skills.*

After the *Fall*, the humans operated at the *Alpha-wave* level or 7-13 cycles per second. These waves are present during dreaming and light meditation. Again, we covered this in TPS:

*As the majority of “neurons” adapt to the Alpha wavelength, alpha waves rotate over the entire brain. The Miller’s believe that it is during the Alpha wavelength that people tap into their “creativity,” which resides immediately beneath the waking consciousness. They state that the alpha wavelength is the “gateway” or “entry point” to “deeper states of consciousness.” The authors also believe that this wavelength is “the home of the window frequency known as the Schumann Resonance.*

There are two obvious questions concerning the forbidden fruit — “If psychotropic plants were so harmful then why did the *angel-watchers* give them to our ancestors?” Moreover, “If psychotropic plants were so harmful then does that mean we should never take mind-altering drugs?” First, the fact that we call it a mistake tells us that it was not malicious. Instead, we think it is a case of the spiritual beings wanting to help speed up our evolution. Until we developed consciousness and emotions, we were unable to transmute them.

An important point is that angels and for that matter all-spiritual beings have a similar consciousness to ours today. We know this because ancient writings, including the Bible, refer to the angels being angry and jealous. Nonetheless, we only see this mentioned after the creation of Adam and Eve. Before that, all references to the angelic realm were as administrators of the Divine Realm. Is it possible that seeing the development of archaic humans the angels just wanted to share their knowledge to “help things along” so to speak, never dreaming of the spiritual ramifications?

Turning to the second question, “If psychotropic plants were so harmful then does that mean we should never take mind-altering drugs? Again, the obvious answer is if the universe did not intend us to use them, they would not be available. The fact they exist, strongly

implies that the plants were there for use at some time in our development, but when?

Shamans have used Psychotropic drugs for thousands of years, the ancient Egyptians and as stated above the cave artists to name a few. Nevertheless, from a consciousness perspective, it was during the 1960s that a major shift occurred in the concept of expanding the mind using psychotropic drugs. Recently, some have used meditation to see UFOs. Yet there are many who have had “encounters of the third kind” without the use of meditation or mind-altering drugs. Considering all of the above leads us to conclude the use of psychotropic plants and or chemically enhanced drugs like LSD was leading to our ability to alter our state of consciousness without drugs. In other words, instead of using drugs to reach a heightened consciousness we will use the meditative practices taught in the *Ancient Mysteries*.

From the excerpts above, we can see that when the *Book of Enoch*, attributes the “watchers mistake” to revealing the mysteries to human beings, it is referring to affecting the sub-conscious of the pre-humans or *Cro-Magnons*. The “mistake” was revealing the psychotropic effect of certain plants, before the *Cro-Magnon* brain was ready. It was disastrous to our spiritual evolution, as the use of these plants led to mayhem in the underdeveloped pre-human mind, taking the level of fear to extremes. Due to the subconscious connection to the Soul Plane, these enhanced thoughts and emotions were able to

permeate and affect the Astral Plane and its inhabitants. Genesis records the consequences, when it reports that certain angels “lusted” after the women, with the result being their offspring, the Nephilim. The Creator/Demiurge took care of the outward effect of this with Noah’s Flood. Unfortunately, the inward or unseen affect was far more serious, as the thoughts and emotions in the Soul Plane took form. Calling this entity the World Soul, the ancients warn that it connects to the subconscious of every human being. As bad as this was, it was not the most serious effect of the “mistake.” The most serious affect was the second part, which lead to the infamous “Fall” of the whole of Creation. Occurring within a thousand years of the “watchers mistake”, the second part was the disruption of the balance between the masculine and feminine through genetic manipulation.

Here was where I made my mistake. Because the mechanics of genetics is extremely advanced for that time, I assumed the perpetrators could not be human. Sadly, I was forgetting how the World Soul could affect the mental development of the *pre-humans*.

It was finding new evidence that showed me how wrong my conclusions were. Again, we record the process in our book *FOR THE CHILDREN*:

In chapter VII's section Forbidden Fruit, we mentioned our discovery of new evidence about the so-called gods of Sumer and Babylon. Surprisingly, it was not through a new book, but instead one over 100 years old.

In 1905, Julian Morgenstern published *The Doctrine of Sin in the Babylonian Religion*, in Germany. As the title implies it is a study on the ancient Babylonian religion. The author believes that ancient writings that referred to the gods were recounting actual historical events.

Since the word worship originates from the word work, it is a fair assumption that the Babylonians did not just worship the gods they literally worked for them. Yet, in these tablets, there is no mention of the gods requiring people to mine gold. On the contrary, the only worship/work Morgenstern refers to is the individual's duty to feed the gods, bread, and wine.

A key point in the tablets pointed out by Morgenstern was the need for purity. The gods required not only the food to be pure, but also the provider. Through this Law, the need for purity came to be associated with performing rituals of purification. Morgenstern observes, "It was first of all his duty to keep himself ritually pure. Any neglect of these duties was sufficient for the food to miss the mark and to cause the anger of the gods."

The Babylonians interpreted impurity as sin, or more accurately 'missing the mark.' Nonetheless, this teaching was far more practical because impurity became associated with sickness. It was akin to the Jewish reaction to lepers. Nevertheless, in these writings we find another level of understanding. Anyone who was impure (sick) was forbidden to participate in any religious rite or service. Instead, their "sin" put them in a kind-of quarantine.

Many of the tablets refer to a person suffering from a sickness as being afflicted with evil spirits. We see this practice in some of the prayers and supplications reported in the book concerning how the populace viewed sickness:

- Mayest thou be freed from transgression, wickedness, curse, sickness, sighing, witchcraft, spell, charm, evil machinations of men.
- Uncleanliness has come against me to judge my cause, to decide my decision
  - Tear out the evil sickness of my body
  - Destroy all evil of my flesh and my sinews
  - May the evil in my body, my flesh, and my sinews on this day come forth, and may I see the Light.

Neighbors also viewed sickness and disease as a person being possessed of the evil spirits; sound familiar? You have only to read the New Testament to read how the ancients attributed Jesus' healing to casting out evil spirits. Compare:

- They put a woeful fever in his body
- A bane of evil hath settled in his body
- An evil disease they have put in his body
- An evil plague hath settled in his body
- An evil venom they have put in his body
- An evil curse hath settled in his body
- Which have been put in the body of the sick man

With Luke 13:11 'There was a woman which had a spirit of infirmity eighteen years, and was bowed together, and could in no wise lift up herself.' In this case, the passage goes on to relate how the Jews castigated Jesus for healing on the Sabbath. His response clearly shows that her infirmity is attributed to evil, although it was not from any fault of her own. Verse 16 has, "And ought not this woman, being

a daughter of Abraham, whom Satan hath bound, lo, these eighteen years, be loosed from this bond on the Sabbath day?'

Ancient civilizations had no concept of bacteria or viruses and could only interpret unexplained experiences from their point of reference. So keeping this in mind, we can perhaps see what they were relating to from our frame of reference. Obviously, anything out of the ordinary to them was supernatural and attributed to the power of the gods. Sickness came on suddenly. As a result, superstitious, uneducated people saw this mysterious evil that afflicted people as the god's punishment. In this way, ancient people saw sickness not only caused by evil spirits, but also attributed it to the gods inflicting individuals with sickness for disobeying them. Morgenstern asserts that for the Babylonians the terms, sin, uncleanness, sickness, possession by evil spirits, are pure synonyms referring to the condition of a the body resulting from "divine anger."

To be honest, like most rational people we never considered sickness and disease as caused by evil spirits. However, working with Phil on his investigation into the teachings of The Alchemical Wedding of Christian Rosenkreutz introduced me to information that made me rethink this assessment. It concerned the teaching on what happens when we sleep.

Anyone studying metaphysics will know that we have more than one body in our energy field. For those unfamiliar with metaphysical teachings, think of the human aura, whose color reflects an individual's mood. The human aura is multi-layered. These different layers represent our individual and unique energy field. The two most relevant to our discussion here are the Astral and Etheric bodies. Phil explains:

*"...when a person sleeps his or her "I" and Astral body detach from the Physical body that remains with the Etheric body in bed. During this time when the two higher entities of a human being have exited the body, higher beings radiate their energies into the sleeping Physical body, regenerating it. As stated, the Astral body records all that has happened during the day, taking the information into the Astral World at night. Regrettably, this means the influence of the*

*higher beings on the Physical body is often hampered because the individual was not true to his or her spiritual self.*

*We discussed how harmful lying was in terms of spiritual progress in the previous day; perhaps this is why Shakespeare was inspired to write “Above all, to thine own self be true.” Along with lying, a more obvious infraction would be violence of any kind, in particular murder. In both cases parts of the perpetrator’s Etheric body separate completely from the body. Floating independently through space, these parts of Etheric bodies are of such a fine substance that they cannot be seen. In reality our world is full of such subtle objects acting as a hindrance to our development. All of this may explain why people see ghosts where severe crimes have been committed.*

*When our actions are so removed from spirituality, such as in war, parts of the Etheric body forced to separate are so dense that they become the smallest molecules; i.e., viruses and bacteria that generate illness, and epidemics.*

*At such times, pre-incarnate souls determine to take on the illness to transmute and dissipate its effect. An example of this could be seen after WWI with the outbreak of Spanish Flu that claimed 50 million lives, predominantly healthy young adults. This was a supreme sacrifice, even if it was unconscious at the human level.”*

Nonetheless, lying and murder are not the only cause for energetic parts of a human being to become germs and viruses. Far more dangerous than either of these is the practice of magic. As stated, the Fall caused magic to enter the world. With the presence of the Shadow, some people were incited to use magic against their neighbors. The direct result was releasing epidemics into the populace, which threatened the survival of our race. It was for this express reason that the ETs came to the Earth 7,000 years ago.

The Babylonian tablets describe how the gods or rather ETs approached the problem. They used holy water. For the gods water was the giver of life, particularly the mouth of the Tigris and Euphrates. In fact, the text according to Morgenstern says, “Marduk is directed by EA to take the water from the mouth of the two streams and with it sprinkle the sick man.” He believes, “This was but natural.



The waters of the Euphrates and Tigris were sacred; therefore efficacious in driving out evil spirits.”

Further on Morgenstern relates that the tablets refer to the use of prayers in conjunction with the water. Over time, people sanctified natural springs using them to exorcise evil spirits. Although, Morgenstern believes the first and therefore purest form of treatment was sprinkling water, the use of sound (prayer) makes sense. When we remember the work of Masuru Emoto, then using sound to purify, or alter water is logical.

The Watcher’s task was to observe the Life-Principle as it evolved on Earth. Consequently, when the ETs saw the consequence of the populace altering their consciousness, they came to try to help. First, they came as kind-of doctors helping the population deal with the epidemic. Could this be why, the tablets report the gods giving the doomed man evil spirits? Obviously, if they were inoculating people and or injecting medicine, to the common person, it might appear that the ETs were causing the illness, especially if the patient died. One of the side effects of magic, so to speak was the destroyer of rational thinking—superstition.

Apart from helping the Human Race survive the epidemics, The ETs goal was also to help the people understand their purpose. Therefore, rather than exploiting Humanity, after the spiritual beings caused the Fall by introducing magic to the world, the ETs began visiting Earth in an attempt to try to mitigate the damage...

My reasoning as I said in my original writing, was only an advanced civilization could perform such acts. When, merely considering how far modern humans came in a little over a century should have alerted me to the error of my thinking.

Another consideration adding to my wrong conclusion was the multiple reports of people's contact with extraterrestrials through meditation and channeling. Again, I did not take into account the effect of the growing World Soul on certain people. We know from archeology and ancient texts that there were several advanced ancient civilizations, such as the Lemurians and Atlanteans, destroyed through natural disasters. In addition, we know that the latter at least dabbled in black magic, involving non-corporeal forces. As the timing for the "Fall" is shortly before the huge leap around 40,000 B.C.E., we know that the culprits could not be the Atlanteans. Therefore, as we do not know the identity, I have chosen to call them Lemurians.

Originally, I deduced that the "aliens" interest in Humanity involves the power of human emotions. Sadly, as I thought they were not human, I did not take into account that the Lemurians could pretend to be extraterrestrials, in not only the real world, but also beyond as agents of the World Soul. Still, I believe, by changing alien to Lemurian we can still use my original reasoning in identifying the cause of the "Fall."

To recap: As stated, only the Life principle within our Solar system contains the divine sparks and until they developed intellect through human beings, the Divine power was unavailable. The power became accessible through human emotions. In reading the numerous channeled books purporting that some outside force was going to save Humanity, one aspect kept repeating itself. What these “benevolent” beings want from Humanity is their emotions. It is through Humanity’s emotions that we discover the real Divine power.

Gautama Buddha taught that suffering releases the soul from *samsara*, or the cycle of rebirth/reincarnation. Many interpret this statement, as meaning life on Earth is painful on purpose. It was only when a soul had learned all the lessons and become disincarnate that the individual could cease experiencing physical life and therefore experience the bliss and happiness of Nirvana or whatever term we use to describe paradise. As the majority of people’s lives were a constant struggle, this gave them hope that their suffering would eventually end. Even so, when we remember that the universe consists of Sophia’s emotions we reveal a deeper

meaning of Gautama's teachings. The Life principle of the Solar system's purpose is to redeem the lost essence of Sophia or divine sparks. Individuals achieve redemption through the Life principle in the form of Humanity transmuting their emotions. In other words, suffering does not release the Spirit or divine sparks, but rather the emotions generated by the suffering. Whenever a person transmutes their emotions, they help change the world and bring paradise to Earth.

At the time of the genetic manipulation of the *Cro-Magnons*, the Creator/Demiurge had an infrastructure governing the evolution of the soul. In this system, the divine sparks through evolution, were slowly re-accessing their spiritual origins. This infrastructure included archons and astrological powers. The Creator/Demiurge had become the impartial judge of the universe, where free will was sacrosanct. With the pre-humans genetic manipulation it meant human beings would no longer gradually incorporate and transmute the emotions of Sophia. On the contrary, individuals were suddenly thrust forward in an unbalanced existence. Sadly, this resulted in the

infusion of the counterfeit spirit, or as we know it today from Eckhart Tolle, the pain-body. This is the subconscious component of the lower ego and both are collectively known as the false self.

Initially, the imbalance between the masculine and feminine only affected the subconscious, but with the development of the self-conscious, the human ego took control.

Although the separation and imbalance within human beings was disastrous for Christ and Sophia's plan, until the Creator/Demiurge adopted mercy no other Divine forces could become involved. Another word for mercy is compassion, which is the epitome of the Christ. Therefore, by adopting mercy, the Creator/Demiurge facilitated the entry of the Christ into our plane. Because the Christ had united with Sophia, with our "Fall" they entered this realm together. Their goal was to teach the Human Race of their spiritual origins, in addition, how to overcome the false self. They accomplished this through the instigation of the Wisdom Religion. Using the energy combination of Christ and

Sophia, the Wisdom Religion, through teachers such as Krishna, Pythagoras, Socrates, Confucius, and Gautama Buddha, taught how we spiritually evolve. Surprisingly, the divine pair was most successful when they inspired an individual. Whenever either the Christ or Sophia actually incarnated as a teacher, it took more time. First, they would have to overcome their human ego/pain body and animal instincts before bringing their chosen vessel to enlightenment. The long path Siddhartha took to become Gautama Buddha is evidence of this.

The human conscience did not emerge until the development of a spiritual soul. It is probable that the allegory of Adam becoming a living soul alludes to this progress. The spiritual soul's development was to assist the Human Race as the redeemers of the divine sparks. It is also important to keep in mind that Humanity has the capacity to create. It should come as no surprise that we do through our imagination, meaning (image made active) which in conjunction with our emotions and intent, co-creates this reality.

When the Lemurians interfered with the Human Race, the Creator/Demiurge reduced the life span and created the Wheel of Necessity or the Law of Karma. In addition, to shield the upper levels from Humanity's depraved thoughts and to facilitate the purification of the Divine sparks, He divided the Astral Plane. He also decided to send a chosen soul, a messiah to help the Human Race. This precious soul that was to sacrifice his life was born as the man Jesus. The sacrifice was required because in the role of the creator of the Law, the Creator/Demiurge could not absolve the Law of Karma. Although the law was there to assist Humanity, because of the aspect of an eye for an eye or retaliation, it had become a vicious cycle. By this time, people saw vengeance as justice, which is why a "sacrificial lamb" was required to absolve the retaliatory part of the law. The Creator tried to teach his children that they should leave the business of vengeance up to him, through Paul's statement "Vengeance is mine, saith the Lord, I will repay." (Romans 12:19)

Previously, I said that we were to vindicate Jehovah and this scripture provides the perfect example. Although St

Paul wrote this in his letter to the Romans, what Craig and I did not realize was that he was referring to the Old Testament. (Leviticus 19:18 Deuteronomy 32:35) Although the latter scripture in Deuteronomy concerns how "Yahweh" will "avenge" Moses, the former in Leviticus is an injunction for constraint. "Thou shalt not avenge, nor bear any grudge..." This sounded a great deal more just than vengeful, not to mention, more indicative of a Divine being. Unfortunately, Humanity wanted injustice eradicated and until they developed mercy could not conceive of the concept that kindness and compassion could "heap fiery coals" (Proverbs 25:22) on their antagonist's head.

This is where the main characters enter history. In our studies, Craig and I had learned that the early church searched the scriptures to find all references to the messiah to apply them to Jesus. Regrettably, this led to the Church making him larger than life, with the doctrine of the Immaculate Conception. With this doctrine, the church distanced Jesus from us as an example of how we would evolve. By making him God,



many people cannot accept his statement that everything he did we could do and more.

A key element of the infancy narratives was to incorporate the fulfillment of the prophecy in Hosea 11:1, which said the father's son, would be called out of Egypt. Let us suppose for the sake of argument that the prophecy is relating to the messiah. If we accept this, is the Gospel of Matthew narrative correct? We would have to say NO, because our studies have revealed that the writers concocted the infancy stories in order to link Jesus to Moses.

Many scholars have hypothesized that Jesus underwent initiation in the Egyptian mystery schools. If he were born in Egypt rather than Nazareth or Bethlehem, it would certainly explain some of the mysterious events in the gospels. Historians record that many Jews settled in Alexandria, Egypt, after returning from exile. In Alexandria were several mystery schools, such as Isis, Dionysus, and Hermes. Is it possible that some of those Jews were members of these mystery or esoteric schools? Several writings point to Jesus and John the

Baptist as being members of an Essene sect. It surprised Craig and me to learn that the sect of Essenes was not restricted to only an ascetic enclave that archeologists found remnants of in Qumran, near the Dead Sea. Apparently, the Essenes also had a following within the general Jewish population and counted entire families as members.

There has been much speculation as to where Jesus was before his baptism by John. Some propose that he was in India, while others favor his originating from Egypt. If we dismiss the infancy narratives (found in Matthew and Luke) along with the story in Luke of Jesus in the temple at the age of twelve, then two of the Gospels (Mark and John) have Jesus suddenly appearing at the river Jordan around the age of thirty, with no explanation. However, fortunately the Gospels are not the only records of Jesus' mission. If we take into consideration other writings, then maybe we can discover why and even explain other contradictions within the gospels, so with this premise in mind, I would like to present a different hypothesis for your consideration.

## **:- THE CALLING -:**

Our hypothesis has Jesus growing up in Alexandria with no idea that he was the prophesied Jewish messiah. As an adolescent, Jesus became a member of the mystery school of Isis and after initiation by the high priestess, trained in the arts of alchemy and magic. This training would explain some of the more mysterious events, such as recorded in John 8:59 where, when the Pharisees tried to stone him, Jesus escaped by becoming invisible to them.

At the same time as Jesus was training in Egypt, his cousin John became a member of an ascetic Essene community. While there, John received a vision informing him that he was to prepare the way for the messiah. At the time, he had no idea the messiah was his cousin Jesus. More than likely, John told his teachers about the vision. Alas, because the Essene leaders were waiting for Elijah to return and John did not fit the expected profile, they did not receive John's revelations well. Instead, they told him to forget the vision and continue his studies.

Preconceptions of even the most well intentioned people can be deadly to spiritual truth. If the people interpreting the Truth are not only wrong, but also people in powerful positions, then it is near impossible for anyone who offers a different interpretation to be accepted. Truth is absolute. Only our capacity to understand the Truth is dynamic. For example, the absolute Truth is that the planet Earth has always orbited the Sun, yet, less than one millennia ago people in power decreed it was heresy to state this Truth. When Galileo dared to challenge this decree, the church accused him of heresy. After his trial decreed he recant, he died a broken man under house arrest. Commendably, Pope John Paul II, not long before his death exonerated Galileo by courageously announcing that those who condemned Galileo were wrong. This is a perfect demonstration of Humanity's dynamic ability to understand the Truth. Today, we can prove Galileo right just by looking through a telescope.

Reminiscent of many people who answer the call, John tried to obey his teacher's instructions, but also like many prophets, he could not ignore the vision.

Meanwhile in our hypothesis, in Alexandria, Jesus' parents wanted their son to know his Essene heritage before he had to marry. (The Talmud recommends that a man marry at age 18, or somewhere between 16 and 24.) Because a family member was already studying at an ascetic order, when he was 20, his parents sent Jesus to Palestine to join his cousin John. Esoteric writings called, *The Essene Gospel of Peace* and *The Essene Jesus* report that Jesus quickly became an Essene master.

Continuing with our hypothesis, eventually unable to deny his destiny, John left the sect and went into the desert. Interestingly a documentary on the Dead Sea Scrolls informs us, there are scrolls saying that if a member of the community broke the rules, the member would suffer banishment to the desert. Could this be why the gospel account of John states that John the Baptist survived in the desert by eating locusts and wild honey? (Mark 1:6)

Ultimately, in the desert, John received inspiration to teach of the repentance of sins and the coming

messiah. He also began baptizing as a symbol for a renewal of life. While baptizing, he spoke of the different baptisms, telling people that he baptized with water but another, which he would identify would baptize with fire and the Holy Ghost. (Mark 1:8) It was important for me to remember that John did not know that he was the reincarnation of Elijah. Like his cousin, Spirit also drove Jesus to his destiny, namely his baptism by John. At that time, Jesus was also unaware of John's former identity or that he himself was the expected messiah.

In the Baptist's vision, John saw the Holy Spirit in the form of a dove alighting and remaining on the messiah, but he had not seen his face. The New Testament says that John recognized Jesus as the messiah before his baptism. All the same, in our hypothesis it was not until after Jesus arose from the water and John saw the dove descending onto him that he knew his cousin was the messiah. Because John denied that he was Elijah, theologians use this to deny reincarnation. Still we need to remember that it was only after John had died and

the experience of the transfiguration on the mountain that Jesus understood both his and John's role.

There has been much debate over what occurred at Jesus' baptism. Putting aside the infancy narratives one would naturally assume that the Christ entered Jesus at his baptism, but that could be misleading. Remembering that the Christ-Sophia unity had secretly entered this world, how do we explain this unique event? Understanding came with the information that the Christ had already entered Jesus before his baptism. If we dismiss the Immaculate Conception, there are no extant writings definitively stating when the Christ infused Jesus. However, upon learning that the age of spiritual decision is 21 years of age, Craig and I recognize that it had to have been while Jesus was with the Essenes. Many scholars have speculated over the identity of the "Teacher of righteousness" mentioned in the Dead Sea Scrolls. Could Jesus have begun his ministry with the dualistic Essenes?

If we recall that Sophia and Christ caused the creation of both the Creator/Demiurge and the universe, and

that the Christ's partner is the Holy Spirit, then the episode at the baptism becomes clearer. Jesus' soul was destined to be the prophesied Jewish messiah. Christ and Sophia had chosen Jesus to be the revealer of the Truth. As with all the other Christs, he had to be anointed for the role. At the baptism, Christ's partner, the Holy Spirit left the Pleroma and rejoined the Christ; creating a Divine power that could transform the man Jesus. The reason, it was so unique was that Jesus' baptism was the unification of the Divine feminine, the Holy Spirit, with the Divine masculine, the Christ.

God gave me the vision of a pearl necklace to explain how the Christ operated on Earth. Individual pearls in the necklace signify that the Christ has taught in various guises, whereas the thread the pearls are strung on represent the Wisdom Religion. Our study revealed a common theme beneath all religions, we understood was the Wisdom Religion. This made perfect sense, as in order for the Christ and Sophia to rescue the divine sparks, they would need to teach Humanity how to overcome the false self (ego/pain body) and bring forth the true spiritual self.



Regardless of the different Christs throughout history and the similarity of their message, Craig and I felt that Jesus Christ was somehow different. It was by understanding the Gnostic teaching of Valentinus that we saw why we felt this way.

As previously stated, apart from the Supreme Being, all emanations had been in pairs, incorporating both masculine and feminine energies. If we recall the whole thing began with Sophia separating from her partner, What-has-been-willed. By the Holy Spirit (feminine) joining, the Christ (masculine) in the man Jesus, the Divine Spirit within his soul was able to gain preeminence. However, a question arises from this. "If the Christ and Sophia were a union, was 'she' in Jesus too?" My answer came upon learning of a legend that Sophia had incarnated into the soul of Mary Magdalene.

The New Testament records that the Spirit drove Jesus into the desert for Satan to tempt him. Nevertheless, Craig and I see this as an analogy of the true spirit of Jesus overcoming the counterfeit spirit, ego/pain-body, or false self. Every human being has to discover his or

her Divine self. Each soul does this by identifying and overcoming his or her Achilles heel or weakness. Because of the kind of temptations Jesus faced, it appears that his weakness was pride. I realize that this sounds almost blasphemous, but in this hypothesis, Craig and I propose that Jesus was a man who demonstrated to Humanity that we must all change the way we think (incidentally, the original meaning for the word repent) to become our true spiritual selves. With this new perspective, we can all realize the need to deal with individual weakness. Jesus was not perfect. You have only to read the gospels to see that several times he showed the false self through human emotions, such as anger, frustration, and fear. If you balk at Jesus having fear, I recommend you read the account of the Garden of Gethsemane. Luke tells us how Jesus “sweats blood” over the thought of his impending death.

Jesus changing water into wine during the marriage feast at Cana, is the first miracle he performs. In the gospel of John, it is the mother of Jesus instigating the “miracle.” Still, Craig and I recently read that the Greek term that is translated into “mother” is more usually

translated as “companion” or “sister.” Hardly the way Jesus would address his mother. However, there is one woman who many writings identify as the companion of Jesus, Mary Magdalene.

Many authors and scholars speculate that the Magdalene was a priestess of Isis. Our hypothesis has Jesus being an initiate of the mystery school of Isis and training in alchemy and magic. I ask, if Sophia had incarnated in Mary Magdalene, is it possible that Jesus knew her before his baptism? Could she have joined him shortly after?

The New Testament is silent on how Jesus came to meet the Magdalene and quite remiss in keeping all the Marys straight from one gospel to the next. We first hear mention of her in the synoptic gospel of Luke. In 8:2, the writer of Luke, after saying “certain women” had been cured of possession in which he includes Mary Magdalene. Luke then adds that Jesus exorcised seven devils from her, before granting that these women “ministered unto him of their substance.” Further study led to the discovery that the Greek term for minister is

*diakones*, from which we derive the English word deacon.

Previously, I wrote that Jesus was chosen to be anointed for his mission. Interestingly, the writer of Luke is the only gospel writer that places Jesus' anointing early in his work. All the other gospel writers place this event at Bethany just before the crucifixion. However, although chapter 11: 1 in the gospel of John has "a Mary" performing the anointing, there is a curious comment in parentheses in the chapter before the anointing. After introducing Lazarus and his sisters Mary and Martha, the text has ("It was that Mary which anointed the Lord with ointment and wiped his feet with her hair, whose brother Lazarus was sick"). This is curious; not only Matthew, Mark and Luke have Simon's house in Bethany where the anointing takes place, but also there is no mention of Lazarus or his sisters at the anointing. Yet in three of the Gospels, Matthew, Mark and John, Jesus uses the same words in addressing the disciples' concerns over the use of such expensive ointment (Spikenard) for the anointing. "For ye have the poor with you always" (Mark 14:7) "For ye have the

poor always with you" (Matthew 26:11) "For the poor always ye have with you" (John 12:8).

Our question was why would the messiah need anointing for his burial? Anointing someone in biblical times signified Divine endorsement. Surely, this had already occurred at the baptism. Nevertheless, if the anointing was to prepare the body for transformation, it makes sense. This would in any case make the anointer of great importance. Was this why the author of the gospel of John wanted to credit this important act with the younger sister of Lazarus and Martha?

We first hear Luke mention Mary Magdalene immediately after the "sinner" who anoints Jesus with precious ointment. Consequently, history has branded her as the penitent sinner. Was Mary Magdalene's anointing Jesus the reconnection between the Christ and Sophia? Moreover, is the reference to exorcizing seven devils, referring to the seven main chakras.

Returning to the "miracle" at Cana, if the person who instigated the event is Mary Magdalene and she was a

priestess of Isis, then she would have known that Jesus was an initiate well-schooled in alchemy. Therefore, she knew it would be easy for Jesus to change the water into wine. Having the gospel of John cite Mary of Bethany, as the woman anointing Jesus, many think Mary of Bethany and Mary Magdalene is the same person. Of course, the Church has encouraged this misidentification. With all due respect, this is an error, as only a priest or priestess could officially anoint someone. We know this is an official anointing by Jesus' words to the disciples. "Verily I say unto you, where-soever this gospel be preached throughout (in) the whole world, this also that (this woman) she hath done shall be spoken (told) of for a memorial of her," Matthew 26:13 and Mark 14:9. Turning to Luke 10:40 Martha, presumably Lazarus' sister, since the passage does not say, complained that her sister, Mary, did not help prepare the meal. Logically, would anyone expect a priestess to help prepare a meal. I would like to propose that there are two "Marys" in the story, Mary of Bethany, the sister of Martha and Lazarus, and Mary Magdalene, the Isis priestess who anointed Jesus.

## **:- THE JOURNEY -:**

For Jesus to fulfill his destiny two things needed to occur. First, John the Baptist needed to depart. We know that the Baptist knew this truth as is shown in his recorded words, "He must increase, but I must decrease." (John 3:30) Some would say that this meant John the Baptist arranged his death.

Those who believe that all events are God's will, would say that Herod Antipas' decision to behead John was also God's will, but that theory would deny freewill. So many times people look to the death of loved ones in a senseless act of violence as the fulfillment of some Divine plan. Because good things often occur through tragic events, many people have used this to support the argument that everything that happens is part of the Divine plan. Craig and I suggest that Divinity only inspires, since this action still facilitates free will. Nevertheless, we have discovered that God is the consummate opportunist. Whenever a dark cloud looms over us, He will inspire whomever, or use whatever He

can to bring forth the silver lining. What is more, God had told us categorically, "Anything that creates fear, hatred and or division is never of Divine origin."

The Old Testament records that two individuals did not experience mortal death, Enoch and Elijah. Remembering that Jesus said that John the Baptist was the reincarnation of Elijah, we ask, is it possible that John could have translated his body, without experiencing physical death again. This would make the beheading of John the Baptist Herod Antipas' responsibility and not any Divine Plan.

After the death of John the Baptist, Jesus took Peter, James, and John to witness the transfiguration. It is during the transfiguration that Jesus revealed his true spiritual essence to his disciples. After this event, Peter declares Jesus as the Christ and Jesus was clearer on his mission and who was involved. For instance, as stated, he knew that John the Baptist was the reincarnation of Elijah. He also knew how his mission would end. All the same, it was quite a lot for Jesus to deal with. How did a mortal man deal with the



foreknowledge of his horrific death? We can attest to firsthand experience that God only tells you what you can handle. He never overloads you. He knows us very well and only reveals as much information as we can cope with. We believe, God simply told Jesus that he would live and to trust Him. (Of course, Jesus' trust proved well placed after the resurrection.)

In the Gospel of John, the writer has Judas Iscariot complaining of the waste of the Spikenard, rather than the disciples. The name Judas has come to be the synonym for traitor, as demonstrated with Dante's "ninth circle of hell" being reserved for traitors like Judas. Nonetheless, many scholars point out that the gospel account seems to have Jesus instigating the "betrayal." According to the gospels, Jesus knew he was to die and that after three days he would appear alive to the disciples. In the gospels, after Peter declares Jesus the Christ, almost immediately Jesus castigates Peter for denying the prophecy of the messiah's death, even going so far as to call him Satan, meaning adversary.

A recent documentary on the “betrayal” and arrest of Jesus, directs us to the fact that Jesus had the opportunity to escape from the Garden of Gethsemane. In fact, as stated earlier he had escaped violence several times previously by “hiding” himself (John 8: 59). Jesus knew that in order to fulfill his mission, he had to be arrested. He even stopped Peter from defending him, telling the disciples if it were not meant to happen, he would have twelve legions (144,000) of angels to assist him. (Matthew 26:53)

I would like to propose this scenario: What if Jesus approached Judas Iscariot to help him, telling him that in order for him to declare himself the messiah, he needed to go before the Jewish authorities. Even more possible what if Jesus told Judas that no one was to know, including the other disciples. This was because he had to fulfill the prophecy and so someone needed to appear to betray him, as per (Psalms 41:9; 55:12-14.) Several scholars connect the 30 pieces of silver Judas demanded as also fulfilling prophecy. It seems to Craig and I that Judas was simply playing the role, in order for Jesus to be recognized as the prophesized messiah.

Many times the foreknowledge of future events can lead to a self-fulfilling prophecy. Jesus, as a trained Essene master would have been aware of all the prophecies surrounding the messiah. Could this have been why he approached Judas Iscariot? Judas was a zealot and saw the culmination of Jesus' ministry as an earthly king. Judas witnessed Jesus' ability to elude his captors and probably thought Jesus was going to reveal who he was by supernatural means. What if, after Jesus' arrest, Judas followed him expecting Jesus to save himself. It must have been devastating for Judas to realize that Jesus was going to be crucified.

For anyone to identify himself or herself as the messiah without proof was considered blasphemy. However, the gospels say that Jesus had proven that he was the messiah several times. Anyone who had traveled with Jesus and witnessed the miracles could have reasonably expected their master to reveal his power. After Jesus was scourged and it became clear what was going to happen, could Judas have asked, "Why didn't he show the Sanhedrin his powers? Why didn't he prove that he was the messiah?"

Something that has puzzled Craig and I is why the Jewish authorities did not recognize Jesus as the messiah and wanted him dead. The New Testament records "miracle" after "miracle", but were they? Other writings state there were many healers in the Holy Lands during the first century of the Common Era. For instance, Apollonius of Tyana, a contemporary of St Paul was known as a healer.

Therefore, I ask if healing was not proof of messiahship, then what is the reason the Jewish authorities feared Jesus so much. I came to understand that it was because Jesus forgave sins. Citizens of Israel and Judea at that time did not have compassion for members of society that were less fortunate. People at that time saw the poor, the sick, and the infirm as deserving of their afflictions because of past "sins." Like the fear of "eternal damnation" today, people of Biblical times believed in the law of karma in that you reaped what you sowed. That is why when encountering a man who was born blind, the disciples asked Jesus "who did sin, this man or his parents that he was born blind?" (John 9:2). By openly forgiving "sins", he was demonstrating

compassion and clearly abolishing the Jewish Law of an eye for an eye and replacing it with mercy and forgiveness. That is why Jesus said your sins are forgiven, whenever he healed someone. Above all else, this challenged the San Hedrin.

Despite the disparaging comments, the gospel writers make against Judas Iscariot, the fact that he had “the bag” (purse or money) speaks volumes to us. You do not give control of your funds to someone you do not trust. Tradition says that after Jesus’ crucifixion, Judas hung himself. As the disciples were unaware of the conspiracy, they saw Judas as betraying the messiah and would have nothing to do with him. Their condemnation after the crucifixion, as much as anything, probably added to the misconception. Is it possible that after the disciples shunned him, Judas left the area and traveled to Damascus?

Regardless of the story of Judas Iscariot’s suicide, by the gospels, the book of Acts may offer another result and show the workings of Divine intervention. In chapter 9 and starting with verse 11, after Saul (St

Paul) lost his sight outside Damascus, a disciple named Ananias received a vision. In the vision Jesus instructs him, "Arise, and go into the street which is called Straight, and inquire in the house of Judas for one called Saul of Tarsus." Craig and I ask, what better way for the compassionate Christ to use this opportunity to teach that even enemies are redeemable? Jesus taught to love our enemies. If the reaction of Ananias to instruction by Jesus is anything to go by, Saul's reputation as a ruthless and relentless persecutor of the followers of Jesus was very widespread. (Acts 9:13-14) By gathering these chosen vessels of Christ at the house of Judas, Jesus was teaching a very valuable lesson of forgiveness to all. God told us that the energy that was in Judas has returned in order to correct a terrible wrong. Could the wrong be history's condemnation of Judas Iscariot?

## **:- THE TRIAL -:**

Now we come to the main event, namely the crucifixion. To state that this was horrific is an understatement in the extreme. Debates have flourished for nearly two thousand years over this day. Many speculate about whether or not Jesus actually died on the cross. They point out the relatively short time he hung on the cross – the third hour until the ninth hour, or 9 am until 3 pm. Typically, it took days for a person to die from crucifixion. As we stated in *Our Story 1995 – 2002: True Philosophers' Stone*, we had puzzled as to why I experienced pain in my right side while on the battlements of the castle in Kyrenia, Cyprus, spoken of in *Our Story 1994: My Lost Love*. After all, the gospels say that Jesus was already dead when the spear was plunged into his right side. The question was answered when we learned of the legend that Longinus, the centurion who pierced Jesus “in the right side” with a spear, was a secret follower of Jesus. Tradition has Longinus mercifully killing Jesus to save him from a

prolonged and agonizing death. This made sense, as medical experts remind us that a corpse does not bleed.

As stated, an innocent soul was required to release Humanity from the Wheel of Necessity or the Law of Karma. So, did Jesus end the Law of Karma? Jesus himself said that he came to fulfill the law not destroy it. (Matthew 5:17) Craig and I believe that Jesus ended the retaliatory component of karma. No longer would individuals who kill have to be killed seven incarnations later. Now karma could fulfill what the Creator/Demiurge intended it to do, help the individual learn from his or her mistakes.

The church today completely denies reincarnation and yet it is obvious that Jesus believed in the rebirth of the soul. Forget the obvious references to John the Baptist as being the reincarnation of the prophet Elijah, (Matthew 17: 11-13) and the question of whether the parents of the man born blind had sinned (John 9: 1-2). Examine what Jesus is saying about Abraham and his references to reincarnation in John 8:56-58. Jesus' statement of existing before Abraham, in the Gospel of



John has done more to support the supposition that God incarnated as Christ Jesus than any other scripture. Even so, I would like to offer another interpretation. It is important to keep in mind that Jesus was dual in nature, with the Christ and Holy Spirit inhabiting his body. Several times in the synoptic gospels, Jesus tells us that the God of Abraham, Isaac and Jacob is a God of the living. He said this for the benefit of the Sadducees, who did not believe in any form of afterlife. By saying that Abraham, Isaac and Jacob were alive, he was stating that these patriarchs had reincarnated. With this point of view, let us reexamine the scripture in John. In verse 56, Jesus says "Your father Abraham rejoiced to see my day: and he saw it, and was glad." Yet in verse 58, he says, "Verily, verily, I say unto you, Before Abraham was, I am." Verse 56 says to us that the reincarnated soul of Abraham knew Jesus. Could he or she (remember that the Spirit is genderless) be one of his followers? When he says in verse 58, that he was before Abraham, we would like to offer that this is the Christ/Holy Spirit speaking through Jesus. Obviously, both the Christ and the Holy Spirit existed before the

universe began. This is why we must always remember the duality within Jesus.

Biblical scholars say that the sky darkening during the crucifixion from the "sixth hour" (noon) until the "ninth hour" (3 pm) signified God raining down His entire wrath on His son. During this time, God abandoned His son. It was at some point in this time that Jesus cried, "My God, My God, why hast Thou forsaken me?" Despite the absolute certainty that No Divine Power is capable of wrath, the scholars are partly correct. The darkness did symbolize the withdrawal of the Light; but it had nothing to do with wrath. Rather, it denotes that the Christ and the Holy Spirit left Jesus the man to face his death alone; hence the anguished cry. All the same, I believe that the merciful Demiurge/Creator moved Longinus to end Jesus' pain quickly.

Since the crucifixion did not follow normal procedure, (typically scavenging animals that feed on carrion would eat the dead bodies) many questioned if Jesus actually died. Of course, after the resurrection these rumors became harder to quell. In fact, if Paul's letters are

anything to go by it was a constant problem. In (Ephesians 4: 9) Paul wrote of Jesus' descent into the "lower parts of the earth." Theologians usually take this passage to refer to Jesus' descent into hell.

Unfortunately, stating that Jesus descended to hell brought in the doctrine of eternal damnation. So what really happened? Where did Jesus' body go? When Paul wrote of Jesus' descent, the concept of hell did not exist in Judaism. Nonetheless, the Greeks did have a concept of heaven and hell, calling the former the Elysian Fields and the Asphodel Meadows, and the latter Hades and Tartarus. To the Greeks, at death everyone goes to Hades, with some remaining in Hades to suffer torment in Tartarus, while those who lived good lives move on to the Asphodel Meadows, or the Elysian Fields, depending on their status, for his or her reward.

Early Church leaders taught that Jesus descended to release the trapped good souls. However, if these "good" souls were already in the Elysian Fields (paradise), why would they need rescuing?

Then, the question is, "If Jesus did not descend to rescue the 'good' souls, then where did he go?" The answer is, into this plane, or time, the future. Remember linear time is only relative to the Physical Plane, in the spiritual realms there is no past, present or future. As we recounted in *Our Story 1995 – 2002: True Philosophers' Stone*, the void is also known as "no time." After the crucifixion, Jesus' soul went to the void or no time and was able to connect to the future on this plane of existence.

Accepting that Jesus' soul went into the void, did his physical body just disappear or become invisible? To be honest Craig and I asked God the same question and He directed us to *The Celestine Prophecy* by James Redfield. This book is an inspired fictional story about a secret manuscript that reveals nine insights of how to develop powers that are natural to the human being. The ninth insight is about developing the ability to raise or speed up an individual's vibration to the extent that they become invisible to those of a lower or slower vibration. Sound familiar? Jesus demonstrated this ability to some extent when he escaped his enemies by

becoming invisible. Obviously though, the resurrection was different.

God told us some time ago that the soul of Jesus had amalgamated with the Christ and became one Spirit. From this, I understand that sometime after Jesus' death, the Christ and the Holy Spirit re-entered his body, raising its vibration to the degree that he became pure light. His physical atoms were transmuted so that he could appear anywhere and in any guise. The phenomenon of Humanity's becoming lighter is a similar process, but the reverse of the fall of certain angels. Today scientific investigation has shown that human beings, despite being 70% water are essentially vibrating energy.

Interestingly, Craig and I discovered that the food we ingest affects the level in which we vibrate. No surprise, the flesh of animals produces the lowest vibration, whereas the highest vibration is from fruit. Could this be why so many people are feeling that it is no longer appropriate to eat the flesh of animals? Might this be why Gautama Buddha would eat no meat? Moreover, is this how we evolve to become lighter beings?

A clear indication that we are energy comes from remembering that doctors consider a person brain-dead when there is no “electrical” activity within the brain. Irrespective of the fact a heart/lung machine is keeping the patient breathing and their heart pumping, the doctor still considers the patient dead.

Speaking of the fall of certain angels, recently it surprised me to learn that some investigators say there are religious writings that report two separate angelic rebellions. As this involves our investigation, we will pause to investigate. Throughout history, artists have depicted Angels in various forms, from cutesy cherubs to awe-inspiring, huge beings of light, but always in human form. Evidently, some of these beings were once corporeal or human beings, and through enlightenment raised their vibration to become light beings. If we return to the beginning of the universe, we can recall that Sophia and the Christ as well as transforming Sophia’s emotions into the four elements of earth, air, fire and water, they caused the creation of the Creator/Demiurge, who instigated the angelic realm.

Consequently, angels were made of the same elements as human beings, only in a more refined, therefore lighter manner. They are also of the Soul Plane and as a result, endowed with souls.

The angelic realm has enthralled us for millennia. Its various divisions have generated numerous writings. The Old Testament is full of angels interacting with Humanity, Jacob's Ladder (Genesis 28:12) and the two angels sent to warn Lot (Genesis 19:1) are just two examples. As I mentioned, artists depicted angels from cutesy cherubs to awe-inspiring light beings. Why such a huge disparity? The reason is that not all angels are equal. We stated that the Demiurge/Creator created the angelic realm; however, he did not create all levels of angels. Before the creation or if you prefer the evolution of Humanity, the lower layers of the angelic realm did not exist. When the Demiurge/Creator was forming the Soul Plane, he brought forth creative (archons) and administrative (astrological) powers. We identify these beings with the suffix "im", such as Elohim, Seraphim and Cherubim. The archangels were formed from early Humanity, before the "fall." As Humanity, evolved

Christ-like teachers taught them how to raise their vibration. This is how humans became angels. Angels were needed to interact with Humanity on a physical level. Because angels consist of the same elements, when the Creator wanted a message given to a person, a messenger (angel) was sent to the person. All the angel had to do was temporarily lower or slow down his or her vibration to the same as the person to be seen and heard. (Note: despite the angelic realm being androgynous, however, when an angel interacts with a human being the angel will appear as either male or female.)

Another astonishing piece of information Craig and I found is that all spiritual beings, along with the Human Race, have free will. As they are beneath the Veil between the Pleroma and the Soul Plane, they are of a dual nature. There is a Jewish legend to the effect that the angels were jealous when Yahweh (the Creator/Demiurge or the God of the Old Testament) asked Adam to name the animals. I can remember commenting on the fact that "angels" could be capable of jealousy. Nonetheless, if we can believe the Bible,



then the angels are capable of more than one “human” emotion. As I said, Genesis reports that some beings of the angelic realm exhibited the emotions of pride and lust.

The axiom, “As above so below, and as below so above” was given to us to help us understand how every ensouled being is linked through the Soul Plane. So we need to always remember that when the Human Race, with its divine sparks was altered genetically, it affected the entire consciousness of the Soul Plane. To reiterate, just as the consciousness of every human being is affected by the mass consciousness, every entity beneath the Veil is also affected. Consequently, when Humanity became infused with the shadow side of the universe through the World Soul, because of the axiom, “As above so below, as below so above,” the Soul Plane also became afflicted. Because every being beneath the Veil has free will, the angels also have to choose urges to which to adhere, self or selflessness. Obviously some of the beings chose self, on record as the angelic rebellion.

Not believing that a Divine being is capable of a punishment like hell, Craig and I wondered what happened to the rebellious angels. Again, only recently, we discovered that there are several writings, which state the rebellious angels, were given corporeal bodies. Remember we said earlier that God told us to think of spiritual forces in terms of energy. This is what we understand occurred. Just as the Christ, with the Holy Spirit, raised or speeded up the cells of Jesus' body, the "fallen angels" affected the opposite by lowering or slowing down their vibrations.

To understand the fate of the "fallen angels" we have to consider that although they are of a finer substance, the angels consist of the same substance as human beings. Furthermore, it is important to remember that everything beneath the Veil is essentially vibrating energy or operating at specific frequency ranges.

Most religious minded individuals think of Heaven as being above us and they would be partly right. The Astral Plane, of which heaven is a part, vibrates at just

a little higher rate than the Earth Plane. Nonetheless, we should view this as within rather than without.

Three subjective levels divide the Astral Plane, which the ancient esoteric teachers named Kama Loka, Avitchi, and Devachan. These three levels, for ease of explanation, are often depicted one above another within this plane. Nonetheless, all three levels are still the Astral Plane. The Church taught that there was heaven, purgatory and hell. Devachan represented the highest level and would equate to the Greek concept of Elysian Fields or the Church's Heaven. No surprise, the reverse side of Devachan, Avitchi equates to the Greek concept of Hades or the Church's Hell. We could view Kama Loka as equal to the concept of Purgatory.

When a spiritual entity through free-will choice begins to slow down or lower their vibration, they sink lower in the Astral Plane. Eventually they slow their vibration to such an extent that they can no longer remain in the subjective Astral Plane and have to take on corporeal bodies in the objective Earth Plane. However, we must assert that as the levels within the Astral Plane are

subjective, an individual's mental conception determines his or her experience in that plane. We should never see the various levels as locations for Divine reward or punishment. Your judgment of your life determines whether you reward or punish yourself.

Belief in places of punishment does more to keep people from God than any other doctrine. So many individuals examine his or her past actions and judge them as unforgivable. Consequently, they decide that as they are already "damned," they may as well enjoy the remainder of their time on Earth. Craig and I would remind these individuals of Jesus' words "Judge not." This injunction is not only to not judge others but also yourself. It does not matter how bad you think your past actions are you can still help change the world. All of us without exception have regrets over things we have done and said in the past. It is important that we all wake up and realize that we are a spirit inhabiting a body and that because the illusion of this world is very seductive; many of us have fallen short of the mark (sinned).

Religion is only the start of the path to spirituality. All of the world's major religions support justice. Where religion and spirituality differ is how we deal with injustice. Even the most radical fundamentalist is opposed to injustice. Like children throwing tantrums by destroying things, they are screaming to be heard. They are looking to their deity (parents) to cure all their ills. Enlightened people must show them that we hear them. Instead of sending soldiers to a country to restore peace, we need to send thousands of unarmed brothers and sisters to work alongside the inhabitants in assisting them to rebuild. Perhaps we could alleviate the problem of overcrowding in the prisons by offering selected individuals the chance to become part of the solution, instead of part of the problem. The only way to silence the rhetoric of the hate mongers is to prove them wrong. What may surprise some people is that the atheistic communists are also struggling on the path to spirituality. Yes, they reject religion, seeing it as the cause of injustice, but they believe in the sovereignty of all people. (Is this not the same as seeing the divine spark in every soul?) They see organized religion as hypocritical. If we look at religious history, we can

hardly blame them; consider the Crusades and the Inquisition, to name but two examples. Unfortunately, the ideal of equality has been usurped by some individuals seeking power and as the saying goes "power corrupts, absolute power corrupts absolutely." Nevertheless, what most individuals have in common is a sincere wish for equality. Affluent countries need to show the rest of the world, we are aware of their plight and we want to help.

As I said, God told us the key to the mysteries, spoken of by Jesus, Paul, and many others, is in the English language. For instance, the words "attention" and "at ease" used by members of the military forces carry a wealth of hidden teaching. When an officer directs his squad to attention, he is requiring them to be alert and observant, they are about to receive vital information. Yet, when the senior officer arrives he often begins by telling the soldiers "at ease," meaning relax. Frequently, when a person dies we say that they are at peace, meaning they are no longer suffering. With the instructions "at ease," despite the modern interpretation of telling the soldiers to relax, originally

the military commander was trying to alleviate any fear the soldiers may be feeling. This is the key to discovering the hidden message. If we replace the word ease with peace, it takes on a completely new relevance. If a person is at peace/ease, he or she is no longer dis-eased. The scripture in 1 Corinthians that asks, "O death, where is thy sting?" (1 Corinthians 15:55) is giving us a vital clue. We can alleviate all dis-ease with the eradication of fear. Chinese medicine teaches that all diseases hold a vibration. To become healthy the Chinese believe that we must raise our vibration to vibrate above the dis-ease and leave the dis-ease behind. This applies to all forms of disease including what Western medicine terms as incurable or terminal. When we are at peace, we are no longer in the grip of fear; therefore, we are no longer dis-eased. This is what Jesus meant by "the peace that passeth all understanding."

As co-creators, the Human Race has been corrupting the Astral Plane with the consciousness of depravity. Understand all thoughts are pure energy and therefore move from the Earth Plane to the higher frequency

Astral Plane. Every angry, vengeful, envious or murderous thought permeates this plane, affecting not only the world's consciousness, but also the entire Soul Plane. What is worse, if any of these thoughts are voiced they then become endowed with even more force. This is the direct consequence of the power of speech.

The designation, "enlightened," has traditionally meant those endued or endowed with Divine knowledge. Still, God told us there is another meaning. Using the key to the mysteries, namely the English language, let us examine the word, "light." Light has two distinct meanings; one to illuminate and the other the opposite of heavy. Most often, we take "enlightened" to mean the taking on of secret, divine knowledge, but we think it is more appropriate to consider the meaning as becoming lighter or less heavy. If everything beneath the Veil is essentially vibrating energy, including spiritual entities, then lightness equates to faster or higher vibration. When the "fallen angels" indulged in human emotions, they lowered or slowed their vibration, becoming heavier until they became of



matter, with corporeal bodies. The same applies to human beings. Whenever a person is filled with love and compassion (in other words, experiencing “the peace that passeth all understanding”), their vibration is raised, which is often experienced as a feeling of light-headedness and described as being “in ecstasy.” On the other hand, anger, hatred, or fear slows or lowers the vibration, which will result in becoming heavier. It is important to reiterate that an angel taking on corporeal form is not the result of Divine punishment meted out by the Creator/Demiurge. Instead, it is simply the consequence of the angel’s conscious choice.

If the fallen angels took on human form could the formation of the World Soul explain St Paul’s injunction in (Ephesians 6:12). In the passage, Paul wrote that we do not fight against flesh and blood, “but against principalities, against powers, against the rulers of the darkness of this world, against spiritual wickedness in high places.”

Could the spiritual wickedness in high places be relating to the powers of the universe testing Humanity?

Although we have come to know the adversary as the one all-powerful evil, the Devil or Satan, as we have said the name originally meant “adversary” or that which is placed in the way. Interestingly, in astrology, the planet Saturn plays that very role. Is this a coincidence? Moreover, is it a coincidence that the Jewish Sabbath is Saturday – Saturn’s Day?

Several years ago, God told us that the members of the Body of Christ have incarnated at this time to demonstrate the power of Love. (I should again stress that the Body of Christ is not restricted to only Christians. Members come from all religions and faiths.) We are to demonstrate Love not only to human beings, but also to all spiritual powers beneath the Veil, including angels and astrological forces. The only tool the Body of Christ has is altruistic or selfless love (agape); the adversaries or opposition has everything else.

With the disincarnation of Christ Jesus, the scripture in Revelation 12:12 comes into play. “Therefore rejoice, you heavens and you who dwell in them! But woe to the earth and the

sea, because the devil has gone down to you! He is filled with fury, because he knows that his time is short."

Jesus' sacrifice had two primary outcomes. First the cleansing of the upper levels of the Soul Plane, which was good. Sadly, as the scripture warns, this meant expelling the densest and worst elements of the World Soul and his minions to the lowest levels of the Astral Plane. At this point, the World Soul becomes the *Shadow of Deception* AKA the "prince of this world," or Eckhart Tolle's *Collective Pain Body* in a fight for existence with the *Light of Truth*. Still connected to every human being through their subconscious, for nearly two thousand years it fed off the depravity of Humanity, by inciting as much atrocity and selfishness as possible.

Jesus' statement that "No one goes to the Father, but by me" was not informing the Human Race that only Christians would go to heaven. Rather, he was saying that only by adopting his words and believing that the kingdom of God is within each individual would it be possible to change the world into a paradise. It is also

important to remember that the Solar System was chosen through evolution to transmute the elements containing the divine sparks back to spirit. As all Christs have taught, we achieve this by becoming selfless.

As I previously stated, every human being has an Achilles heel or weakness. When a person identifies their weakness and initiates direct two-way communication with God, whatever the Divine is to you, he or she changes his or her vibration. Mel Gibson's *The Passion of the Christ* greatly assisted in the process. Literally millions of people were moved to tears of compassion for Jesus' suffering, and this is the reason we can change the world. By experiencing compassion, we touch the more painful emotions inside. Then we transmute those feelings by the act of helping and caring for others.

## **:- The Reunion -:**

We have come full circle. Did anyone see the significance of the Olympic Games returning to its birthplace of Athens, Greece in 2004? While watching the Olympic Games, Craig and I were struck by the number of men openly showing emotion. Obviously, this is a sign that we no longer see showing emotion in public, as "sissy." What a relief.

The film *Pay it Forward* with Kevin Spacey and Helen Hunt has a message for what Humanity needs to do at this time. Instead of repaying a kindness, which stops there, the story directs us to help another three people, who in turn help another nine people. This signifies progression, which is the goal of spiritual evolution.

It is time for us to follow Jesus' example. His resurrection showed us the way. When Jesus told Mary Magdalene not to touch him, he was only just starting the process of transformation. This statement tells us that after the resurrection, although Jesus was energy, his energy was unstable. Nonetheless, eight days later

the energy had stabilized so that Jesus could tell Thomas to place his fingers in the nail-prints of Jesus' hands. Moreover, Jesus urged Thomas to put his hand into the wound in his side (John 20: 27). This appears to signify that after eight days it was okay for Jesus to interact with others.

While Jesus appeared to the disciples in the form they knew in the "Upper Room," he often appeared in a guise that they did not know. For instance, at first, Mary Magdalene did not recognize him. (John 20:15) Another example is that two of his disciples walked with Jesus on the road to Emmaus without recognizing their teacher. (Luke 24:15-16) Finally, Jesus appears on the shore and the disciples only recognize him by his words. (John 21:1-12) What did this mean? It seems to me that Jesus did not have the same physical appearance. With these events, Jesus was demonstrating that the soul and spirit are not the physical body.

According to the book of Acts, Jesus remained teaching the disciples for forty days, (Acts 1:3) yet the New Testament only records a handful of sentences of this

time. Still, as I said, there were writings that recorded the teachings of Jesus after the resurrection. The Church fathers eventually called these writings heretical and attempted to destroy them. Then again, “the Truth will out” and as we said, in 1945 a local discovered several of these “heretical” writings in Nag Hammadi, Upper Egypt. Many of the writings depict Mary Magdalene as taking a leadership role. In fact, we learned that the early Church fathers knew her as the Apostle to the Apostles.

An obscure writing called the *Pistis Sophia*, which means Faith-Wisdom, known as a Gnostic miscellany, contradicts the general opinion of Mary Magdalene. Containing a discourse between Jesus and his disciples after the resurrection, the participants in the book include Mary Magdalene and other women. The discourse centers on Jesus asking the disciples questions on the repentance and redemption of Sophia. Several times, Mary Magdalene answers Jesus. On one such occasion, he addresses her in an extraordinary way. “Mary, thou blessed one, whom I will perfect in all mysteries of those of the height, discourse in openness,

thou, whose heart is raised to the kingdom of heaven more than thy brethren." Another time, Jesus refers to Mary Magdalene as "inheritress of the light."

Before continuing, a salient point needs clarifying here. Previously, I stated that there was no past, present or future in the Divine realms. The First Father had the Limit instantly restore Sophia to her place within the Pleroma after her folly. As we said earlier, life began when Sophia separated from her partner What-has-been-willed. Beneath the Veil, everything exists in linear time, as such, the time Sophia was experiencing fear, grief, ignorance, and confusion encompasses the entire existence of the material and Soul planes. In other words while in the Pleroma, the episode was a mere blink of the eye so to speak; whereas, beneath the Veil, the entire existence of the universe had elapsed.

It is almost impossible for a person, whose life span extends to, at the most a little over a century, to conceive of the vast eons of time involved here. To put this in perspective: in esoteric terms or manvantaric,



(the Hindu term for a cycle of time) a “life of Brahmâ” or the life of the universe consists of four billion, three hundred and twenty million, (4,320,000,000) multiplied by seventy-two thousand, (72,000) years. The human genus *Homo*, of which our species *Homo Sapiens, sapiens* is the result, has only existed for five million years.

Previously I stated that the Divine powers could not help until the Life principle developed intellect and self-awareness, and the Creator/Demiurge adopted mercy or compassion. It was then that the Christ and Sophia could begin to wake up the dormant sparks. They did this by teaching human beings of their spiritual origins through the Wisdom Religion, the esoteric base beneath all the world’s main religions. Despite the confusion with Jesus’ teachings, he was the culmination of this process.

The Gnostics reported that Jesus taught his disciples of the fall of Sophia. If we remember the legend of Sophia incarnating in Mary Magdalene, we can see why he would use the epithet “inheritress of the light” with

respect to her, related in *Pistis Sophia*. Jesus the Christ teaching Mary Magdalene was symbolic of Sophia's redemption. This is another instance of the axiom "As above, so below, as below, so above," which is demonstrated through Mary Magdalene's being the earthly counterpart to Sophia.

"As above, so below, as below, so above," was thought to mean that everything that happens on the material plane occurs on the Spiritual Plane and vice versa. Nevertheless, there is another way to think of it, and that is balance. Earlier we mentioned that we could consider the Gnostic emanations as partners of opposites working in unison together.

Sophia's separating from her partner, What-has-been-willed, caused the creation of the material universe. As Craig relates, "The pairs in the Gnostic Pleroma set up a situation much like dissimilar voltage potentials cause current to flow in an electrical device. So we could see the axiom, 'As above, so below, as below, so above,' as the pattern for the flow of all energy, including matter in search of balance or peaceful equilibrium."

Due to writings such as the *Pistis Sophia*, many have speculated on the relationship between Jesus and Mary Magdalene, with some deducing that they were married. True, the Jewish custom was for a man to marry between 16 and 24; nonetheless, if Jesus entered the ascetic Essene sect then no one would expect him to wed. Could the connection between Sophia and the Christ have led to the supposition that Jesus and Mary Magdalene were married? If Sophia was incarnate as Mary Magdalene and the Christ was Jesus, could this be why some of the legends claiming they were married have persisted?

Most advocates for Jesus and Mary Magdalene being married point to a telling statement in the Gnostic *Gospel of Philip* (One of the *Nag Hammadi Library* texts). Concerning Mary Magdalene and Jesus' relationship, it reads; "But Christ loved her (Mary Magdalene) more than all the disciples and used to kiss her often on the -----." There is a hole in the manuscript and so we must speculate as to where Jesus used to kiss her. Most people think that the missing word is "mouth." This is logical, but nonetheless, if we

read on, the manuscript has an amazing statement. "The rest of the disciples were offended by it and expressed disapproval. They said to him, 'Why do you love her more than all of us?' The Saviour answered and said to them, 'Why do I not love you like (I love) her'?"

Obviously, a man would not feel the same for his companions as he did for his wife, or even girlfriend. Therefore, for writers to suggest the disciples "were offended" when Jesus kissed his wife, was specious. However, *The Gospel of Mary* (Magdalene) may shed some light on the reason for the disciples' animosity towards her. "Peter said to Mary, 'Sister, we know that the saviour loved you more than the rest of women. Tell us the words of the saviour which you remember – which you know (but) we do not, nor have we heard them.' Mary answered and said, 'What is hidden from you I will proclaim to you'."

After Mary recounts a vision in which the risen Christ appeared to her, teaching of secret mysteries, Andrew and Peter immediately challenge her veracity. The text

continues; "When Mary had said this, she fell silent... But Andrew answered and said to the brethren, 'Say what you (wish to) say about what she has said. I at least do not believe that the Savior said this. For certainly these teachings are strange ideas.' Peter answered... 'Did he really speak with a woman without our knowledge (and) not openly? Are we to turn about and listen to her? Did he prefer her to us?'"

Obviously, this is very distressing to Mary and she replies, "My brother Peter, what do you think that I thought this up myself in my heart or that I am lying about the Savior? Levi (Matthew) answered and said to Peter, 'Peter, you have always been hot-tempered. Now see you contending against the woman like the adversaries. But if the Savior made her worthy, who are you indeed to reject her? Surely the Savior knows her very well. That is why he loved her more than us'."

To understand why the disciples were "offended" when Jesus kissed Mary Magdalene, we need to understand the Middle-Eastern culture. In the West, heterosexual males do not kiss each other in private let alone in

public. However, in the Middle East men regularly greet each other with a kiss on the cheek. Remember, Judas kissed Jesus on the cheek to identify him to his enemies in the garden of Gethsemane. (Matthew 26:48-49) For Middle Easterners, to kiss someone on the mouth in public is a sign of extreme respect. Therefore, if Jesus kissed Mary Magdalene on the mouth in front of the other disciples, he would have been demonstrating the highest honor and acknowledgment of her as his pupil. Accordingly, some of the disciples were jealous of her.

Another reason the relationship between Jesus and Mary Magdalene has been thought to be carnal, is that the mystery schools practiced a mystical sexual union called (*hieros gamos*) between the high priest and priestess. This ritual symbolically represents the union between the masculine and feminine deities. Engaging in this sexual union, was the way for the high priest and priestess to connect to the Divine. However, like many ceremonies throughout the world, there is a physical and a spiritual component. Craig and I would like to present the spiritual and the higher, non-physical meaning for the *hieros gamos* ritual.

Accepting that both Jesus and Mary Magdalene were initiates of the Isis mystery religion, this means it is possible, if not likely that Jesus was aware of the practice of sex magic. Could the reference to his exorcizing seven devils from Mary be referring to this? After all, the purpose of the ritual of *hieros gamos* between an initiated priest and priestess was to raise the Kundalini, otherwise known as a coiled serpent of energy at the base of the spine. The goal was to raise the energy from the first or base chakra through all "seven" chakras to the seventh or crown chakra at the top of the head. However, if this ritual was attempted and one or both of the participants were impure, then instead of raising the wise serpent, they would raise the dragon of passion, which would quickly dominate the body.

This hypothesis proposes that whether or not Mary Magdalene knew Jesus, when she learned of his ministry she hurried to his side believing that, as Isis initiates they needed to perform the ritual of *hieros gamos*. However, when she reached Jesus, he taught

her that the goal of the enlightened was to connect to God through the heart, not the physical passions.

Although Mary Magdalene went to Jesus to anoint him, as with Jesus, she was unaware of the deeper spiritual implications. Instead, she was merely following a blind directive. Mirroring Jesus and John the Baptist's experience, Mary Magdalene was as equally unaware of the spirit she carried or her divine destiny. Therefore, applying the axiom of "As above, so below, as below so above," Jesus' teaching Mary Magdalene was the beginning of the redemption of Sophia.

Previously, I mentioned that early Humanity tried to emulate the Divine world by installing a king and queen or emperor and empress to rule their civilizations. Throughout the world, myths and legends of gods and goddesses retained the knowledge of the Divine union of Sophia and the Christ. At a subconscious level, the Human Race knows of the Divine union, however, they have seen that union only in physical terms. Then why did Paul write, "flesh and blood cannot inherit the kingdom of God," in 1 Corinthians 15:50? Considering



the risen Christ taught Paul, this is quite a statement. By this, Paul stated categorically that the mystical sexual practice of *hieros gamos* or Sacred Marriage was not the way to connect to the Divine. So if the Sacred Marriage or Union was not about physical union, what was it about?

The fact that Jesus spoke of the Sacred Marriage gave the advocates for Jesus and Mary Magdalen's marriage, ammunition. Still if by the Sacred Marriage, Jesus meant the union of spirit and matter, or rather the spiritualization of matter, it changes or rather spiritualizes it. Could this be why the ancient symbol for this union is the interlaced triangles or the six-pointed star, the top triangle signifying the descent of Spirit into matter and the lower triangle signifying the ascent of matter to Spirit? Could Jesus be saying that the ancient rite of *hieros gamos* (Sacred Marriage) was not about physical sexual union, but rather about Divine Love and the unification of the masculine and feminine within each of us?

Recently, God reminded us that there are three primary Greek words for love: eros, philo or *Philia* and agape. Greek scholars today tell us that there is a fourth term *Storge*, representing a parent's love for his or her child. However, for our purposes, my interest is in the message the three primary terms convey. We learned that eros, from which the word "erotic" derives, represents the three lowest chakras, base, sacral and solar plexus and the five senses i.e. purely physical love. Philo, from which we derive the word philosopher, on the other hand symbolizes the three highest chakras, throat, third eye and crown and the two senses of sight and hearing. Interestingly, philo signifies mental love, which means a mental choice. Unlike eros, where all five physical senses are involved, philo love involves only two senses, sight and sound. Philo occurs with a calculated mental choice, which we could view as love for inanimate objects, or nature. So much for eros and philo, what about agape. Apparently, we do not generate agape love with either physical sensation or mental calculation, but through compassion. It is symbolized by the heart chakra. The Gospel of John records Jesus as saying "greater love hath no man than

this, that he lay down his life for his friends." From this we understand, agape is completely selfless love. We could describe a person running into a burning building to rescue a stranger without thought for his or her own life as demonstrating agape love. Nevertheless, it is through the unification of all three forms of love that the *hieros gamos* or the Sacred Union or Marriage occurs. It seems relevant that the symbol for the heart chakra, the chakra that lies between the three lowest and the three highest chakras, and representative of *hieros gamos* is a six-pointed star.



## **:- The Lesson -:**

For our hypothesis to work, I need to address an important question, "What happened to the disciples?" Mark 3: 16-18, lists them thus: Simon Peter, James and John Zebedee, the sons of thunder, Andrew, Philip, Bartholomew, Matthew, Thomas, James the son of Alphaeus, Thaddeus and Simon the Canaanite. Of course, Judas Iscariot was on the list, but as we have already covered his fate, I will not include him.

Curiously, only the fate of nine of the disciples was recorded, in *The Golden Legend: Readings on the Saints*, considered the authority by the Church. Thaddeus and Simon the Canaanite were not even mentioned.

According to *The Golden Legend*, initially Andrew joined Matthew in Ethiopia, but later when Matthew left for Antioch, Andrew went to Achaia. There appears to be great confusion over the leader of the Jerusalem Church. Tradition holds Peter as leading the first church in Jerusalem with John and James the brother

of Jesus. However, the New Testament appears to say that at first, Jesus' family did not support his ministry. (Mark 3:31.) Apparently, ignoring the contradictory scripture, *The Golden Legend* makes the disciple James the son of Alphaeus the brother of Jesus.

Josephus, a Jewish historian that wrote in the first century, reports of a James the Just becoming the head of the Jerusalem church, after Jesus departs the scene. Josephus does not mention Peter or John. Acts relating that Peter traveled extensively with John seems to support this. As there were two disciples named James, one was assumed to have been the brother of Jesus. Nonetheless, as neither of the disciples were the son of Joseph, this is curious. Even if we accept that Jesus had only half brothers and sisters, his half siblings would have been the sons and daughters of Joseph.

The book of Acts reports that in Samaria, Peter and John dispute with Simon Magus. However, the Gospel of John recounts that Jesus entrusted John with his mother. According to the *Golden Legend*, John is

reputed to have journeyed to Asia to teach there. James the brother of John was supposed to have taught in Samaria before traveling to Spain to teach. Even so, Acts holds James, the brother of John as being martyred by Herod Agrippa. Thomas was rumored to have journeyed to India. Like Thomas, Bartholomew was also thought to have gone to India. Interestingly, because vestiges of Jesus' teachings have been found in India, many formed the supposition that Jesus was there before his baptism. Perhaps the apostle Thomas and Bartholomew traveling to India might be the reason why, Jesus' teachings were found there. According to *The Golden Legend* Philip, who had been in Samaria, went to Gaza, later settling in Caesarea.

Regarding Mary Magdalene, as I have already stated, the Church obscured her identity and discouraged the thought of her as a separate individual. *The Golden Legend* also labels her as Mary of Bethany and records her traveling to Gaul/France. Irrespective of the Church's misdirection, there are other legends that have Mary Magdalene traveling to Ephesus with the

mother of Jesus. In conclusion, it seems that there is very little clarity as to exactly who many of the disciples were, let alone where they all ended up.

Craig and I think that *The Golden Legend* is probably the main source for Mary Magdalene's connection to Southern France or ancient Gaul, as it was called in Roman times. Despite this, we need to remember that Mary Magdalene was not called the "Apostle to the Apostles" for nothing. Regardless of the Church's making her the repentant sinner, early Christian sects held that she was a teacher in her own right. An interesting comment in *Pistis Sophia* has Jesus commissioning Thomas, Matthew, Philip, and Mary Magdalene to spread his teachings.

Regarding the Magdalene being labeled the "penitent sinner", I think the *Pistis Sophia* can help. This strange Gnostic miscellany has Sophia going through extended "repentances" before being reaccepted into the Pleroma. Recalling the legend of Sophia incarnating as Mary Magdalene, I wondered if this could be why multiple art works portray her as "repenting." As for



the reference to Mary Magdalene going to France, I believe it comes from the deliberate confusion over the identity of Mary of Bethany, Lazarus' sister. To reiterate, the Gospel of John is the only gospel that says the sister of Martha and Lazarus anointed Jesus. A possible answer to the controversy came when Craig and I learned that Lazarus with his sisters Martha and Mary traveled to Gaul with Joseph of Arimathea.

We have read several books recently that speculate that Mary Magdalene was not only Jesus' wife but that she was also pregnant with his child. According to several authors, including Dan Brown in his famous best seller, *The DaVinci Code*, this child's descendants are the Merovian kings and queens of France. Making Mary Magdalene pregnant with Jesus' child, greatly diminishes the purpose of his ministry. Jesus' fundamental message was to teach that everyone is able to connect with the Supreme Being.

Due to the supposition that Jesus fathered a child, many people focus on the physical man and his bloodline and in some circles, whether or not Jesus

was married has become of more importance than his message. Remember, "flesh and blood cannot inherit the kingdom of God." Unfortunately, we see this in the early Church reverting to the Jewish custom of circumcision (Galatians 3:2-11) and putting great store in bloodlines. Observe the genealogy recorded in the gospels of Matthew and Luke, of which even the pseudo Pauline gospel of Timothy warns. (Timothy 1:4) Because of this custom, immediately after the resurrection, James the Just, the brother of Jesus, was declared the new leader of the Jerusalem Church. Furthermore, according to Eusebius the Church historian, after James' death, every male member of Jesus' family was installed as the leader of the Jerusalem Church.

Gnostic teachings, or as the Church labelled them, the "heretics" had Peter, Andrew and James taking early Christianity back to its Jewish roots. Alternatively, Mary Magdalene came to represent the Gnostic or non-Jewish side of Christianity. This is interesting, as Saint Paul, the Church's champion, also seems to be moving Christianity away from Judaism and towards

Gnosticism. I guess, the question we need to ask is, "Why did Jesus Christ call Saul/Paul to God's service?"

As stated, Acts records Jesus as ascending after teaching his disciples for forty days and immediately after the Holy Ghost or Spirit is poured out. In Acts, it appears that the Spirit only fills the twelve disciples assembled in the "Upper Room," and later refers to them as Apostles. They then impart the Holy Spirit/Ghost to others by the laying on of hands. However, St Paul seems to say that all believers receive the Holy Ghost/Spirit.

The Gospel of John reports that Jesus promises the disciples to ask the Father to send "another comforter." *Paraklētos* is the Greek word for Comforter in the text. Interestingly, *Paraklētos* literally means, "One called alongside to help." The Church interprets this passage as the coming of the Holy Ghost at Pentecost, and they are partly right. Because the divine sparks are hidden within Humanity and the Supreme Being emanated the Holy Spirit, the Comforter is the Holy Spirit residing in each

individual's heart. This connection links us to God and helps each human being make the best decision. It is fully activated by an act of selflessness or compassion. Still, if we read Jesus' description of the Comforter, it is obvious that he was referring to an actual person: "But the Comforter, which is the Holy Ghost whom the Father will send in my name, he shall teach you all things, and bring all things to your remembrance, whatsoever I have said unto you." (John 14:26)

After St Paul's conversion Acts says that the disciples of Jerusalem were afraid of him. It is only when Barnabas reports Paul's preaching and takes him to the Apostles that they accept the Pharisee. (Acts 9: 26-27) If we recall, Jesus appeared to his disciples in such a way that they did not recognize him. Saul/St Paul arriving in Jerusalem repeating Jesus' words must have given them pause for thought. Could the disciples have wondered if Saul was Jesus returned?

The description of "the third member of the Trinity" has caused a great deal of confusion. Craig and I have spent many hours attempting to ascertain the

difference between the Holy Spirit and the Holy Ghost. Our answer, when it came was so simple; it is all to do with the difference between the words spirit and ghost. Most people understand that the “unseen” spirits of departed loved ones are with them, watching over them. Whereas, the haunting of a ghost is described often as a filmy/shadowy specter or ghost that is “seen” by the living. Acts describes Pentecost as flames settling on the disciples’ heads, in other words something visible. Craig and I believe this was the Holy Ghost, namely a tangible force empowering them to heal and speak to the populace of all lands. Alternatively, the Holy Spirit is the Divine energy poured out on all Humanity at Pentecost. We could view the Holy Ghost as the designation for the Holy Spirit in physical form, i.e., when “she”, remember she is the feminine side of Christ, is infused in a person. An example of this occurred with Jesus and Saul/Paul and the disciples at Pentecost. However, we need to remember that after Jesus’ baptism the Holy Spirit reunited with the Christ, consequently, both Jesus and Saul/Paul became infused with the Divine partnership.

In *LOVE The Common Denominator*, I reported that the pseudo Clementine Homilies likened Saul/St Paul to Simon Magus. The Homilies accuse Simon Magus of crimes that the Jerusalem disciples later attribute to Paul. Craig and I were surprised to learn that Helen, the woman travelling with Simon, was likened to Mary Magdalene.

Professor Elaine Pagels, an accredited authority on Gnosticism, who I have already mentioned has said that St Paul used Gnostic terms in his letters, (see 1Corinthians 3:1). If St Paul did travel with Mary Magdalene, it would explain why the Church attacked them under the names of Simon and Helen. Many Gnostics claim that they take their teachings from Paul. In fact, as stated, Valentinus claimed to have been taught by Theudas a disciple of St Paul and as the *Pistis Sophia* reports Jesus taught about Sophia after his resurrection, passing the baton, so to speak to Mary Magdalene. Could this be how St. Paul also learned about these controversial teachings? The whole premise of the Gnostics was one of self-responsibility. Gnosticism held that Jesus showed us the way.

Salvation is in our hands. At the time of St Paul, the Jerusalem Church was gaining both converts and wealth. If Gnosticism had prevailed, there would have been no need for a hierarchical Church.





## **:- The Fullness of Time -:**

Almost two thousand years ago, the Universal Christ and Holy Spirit together with Sophia, put into motion through Jesus and Mary Magdalene, the means to end suffering. When Jesus sacrificed his life, he ended the law of an eye for an eye, a life for a life. By revealing Humanity's true origins, he gave us the tools to change this world. Until then the prophets taught people to fear God and worship became synonymous with appeasing the "wrath of God." Jesus, with the Christ and Holy Spirit, taught how to transcend suffering through selflessness and compassion. He demonstrated with his actions how we should show compassion rather than judgment for our fellow human beings. To bring the kingdom of God into the world takes selfless Love, then God is truly present.

As this is the Fullness of Time, we have the opportunity to understand the Christs' assertion that the kingdom of God is within us, from a scientific perspective. All the Christs have talked of the gate we must enter.

Researching the gate Craig and I discovered each Christ-like teacher was referring to the heart-gate. In other words, after we transform the heart, we enter through the heart-gate into the kingdom of God, which is inner space, not outer space. Through the innovation of quantum physics, we now know that there are worlds within worlds. The sub-atomic particles of the quantum physicists are the same as the elementals of the Mysteries. To understand how there is consciousness at the subatomic level Craig and I recommend you read Michael Talbot's brilliant book *The Holographic Universe*.

Today, we understand that emotions have an effect on the physical body. Moreover, through the groundbreaking work of Masaru Emoto, we have the opportunity to see the effect different thoughts and words have on water molecules during the freezing process. Remembering that a human being is 70% water, this a sobering thought. (This is not mystical supposition, but a verifiable scientific fact.) In addition, the work of the Institute of HeartMath has shown that the human heart emits a magnetic field stronger than

the human brain. Could this be why Jesus warned us to be careful of what came out of the heart?

Change begins with one person. Witness the achievements of Mahatma Gandhi and Dr. Martin Luther King Jr. If we always keep in mind that we are energy and consciousness, we will realize that one person can affect the mind and heart of the planet, metaphorically speaking of course. Moreover, if we examine the Gnostic belief that the Christ, together with Sophia transmuted her emotions of fear, grief, ignorance and confusion into the four elements, we can see how this world can change. Philosophers divide the material universe into Love and Fear, consequently, when a person lets go of fear, they fill their heart with Love.

The Gnostics believed that salvation came through gnosis. As we wrote in *Our Story 1995 - 2002: True Philosophers' Stone*, experts most often translate gnosis into knowledge, but we feel a more appropriate translation is, knowing. With knowing our true origins, ignorance and confusion disappear. In addition, the

grief of separation from God also disappears. Furthermore, if Irenaeus, the great Church father and heresiologist, is right when he wrote the Gnostics believe all evil originates from grief, then “evil” will also be transmuted. The key is releasing fear, which is at the base of all the emotions we need to transmute. Remembering that the main constituent of all living beings is water and that Sophia’s fear became water, not to mention the photographic evidence of Masaru Emoto, we can see why releasing fear will change the world.

Humanity’s consciousness is connected. Most of us experienced this immediately after 9/11, through our collective suffering. Sadly, this connection did not last because the shock and horror eventually dissipated, causing many to go back to their individual lives. Obviously, anyone witnessing the tragic loss of loved ones or friends in the attacks has the vision of the towers falling burned into their consciousness. Nevertheless, for most, we “witnessed” the horrific events on television. Unfortunately, through watching horror movies and atrocities on the nightly news,

many have become numb to the suffering of others. I am not for one minute comparing the terrible events of 9/11, with watching a movie; I just want to give you a visual analogy to explain my point. Still, there were a number of individuals among the witnesses and many people who did not personally see the attacks, who had a different perspective. Demonstrating Jesus' injunction to Love and forgive one another, these individuals felt genuine compassion not only for the victims of the attacks, but also the families of the hijackers. This is key because their compassion was for all concerned and therefore had a stronger impact on the world's consciousness. These people affected the powerful connection nearly everyone experienced. Alas, the constant reporting of the risk of another attack quickly turned the compassionate connection to fear for those that only felt for the victims of the attacks. For this reason, the world soon degenerated into fear, with all the emotions and feelings that go with it, such as, anger, hatred, vengeance and judgment. Whenever we experience compassion, it takes a great deal fewer individuals to influence change. Gary Zukav in the *Seat of the Soul* says that

the world reflects the consciousness of Humanity. For instance, if most of the people feel hatred and anger it translates into wars and violence. Conversely, if the majority of people have compassion for their fellow human beings, we reflect that in the world.

Every soul born between 1945 and 1983 has returned at this time not to balance their personal karma, but to assist in the spiritual evolution of the Human Race. Baby boomers were the first generation of souls to mature during the sixties, with the hippies and the flower children. Despite many historians making the effect of the flower children synonymous with the revolution of sex, drugs and antiestablishment, this generation was trying to teach the world a valuable lesson. The communes that they founded showed that if we stopped focusing on our differences, we could live in harmony with both nature and each other. Another thing this generation taught the world was that the power of the people is in their voices and not their fists. Of course there were some individuals connected to the movement that were set on violence, nevertheless, the majority of young people advocated

peaceful demonstration. Most of those hippies and flower children are in their sixties now and need a reminder of the goal they held true during the summer of love. The ideals they held during this time were the ideals taught by all the Christ-like teachers throughout history. When their dreams did not materialize, the hippies and flower children faded into obscurity believing that the dream could never become a reality in their lifetimes. Many settled into a conventional life helping the dream in any way they could, through supporting the various charities. Thank God for them, because without the charitable organizations, the plight of the poor, sick and disenfranchised would be a great deal more serious. Unfortunately, charities only relieve the symptoms without curing the disease. This is tantamount to putting a Band-Aid over a festering wound, the wound looks clean from the surface but underneath the infection is growing.

When God told Craig and me to form the I.D.E.A Foundation for the Benefit of Humanity, we understood that rather than relieving symptoms we were to work to cure the disease. We are not alone in thinking that

the most deadly diseases affecting the world are indifference, apathy, greed and selfishness. The world was not ready to rip the Band-Aid off during the sixties, but this is the Fullness of Time and it is now the real dawning of the Age of Aquarius.

After Craig and I opened the 7 Keys Millennium Awakening Center, we had a person commissioned to create a logo for the center. The woman chosen for the task attended the same shamanic class that we had in 1999. Her logo contained the 7 Keys, which alluded to the seven Keys of interpretation of all scriptural allegory. Regardless of the validity of the meaning, when we adopted the logo for the I.D.E.A. foundation, God told us that the symbol contained a far deeper spiritual meaning. The symbol also stood for the seven Keys to Love and the seven points to Truth. Dealing with the latter first the seven points to Truth are Objectivity, Discernment, Impartiality, Honesty, Curiosity, Awareness, and Wisdom.

Seems clear enough, but the seven Keys to Love posed a much more difficult question for us. Today, we



use the word Love to describe almost every strong desire and or affection for a person or object, but how can the Supreme Being be an emotion? The master key, to use a euphemism, turned out to be the identification of Love as a state of being, which we achieve through the Sacred Marriage or Union. The New Testament refers to God as Love (1 John 4:16) and so to achieve union with the Heavenly Father, an individual must foster the 7 Keys of Patience, Forgiveness, Kindness, Humility, Understanding, Altruism, and Compassion.

This is what Jesus and all the Christs of history have been telling us. It is through the Sacred Marriage or Union we change the world. By combining all three aspects of love, we no longer objectify Love; we become the quintessence of Love, which is a state of being. It is only then that through altruism, compassion, and selflessness that all suffering ends.

Considering the ideals of such a large number of individuals during the sixties, it is hard to understand what happened. It was not until we learned of the

importance of astrology in evolution that the light went on for us. There are three major transitions in a person's life, astrologically speaking. The Saturn Return, which occurs when the planet Saturn returns to the position it was at your birth, this event happens around twenty-nine years of age. Your Uranus Opposition occurs when the planet Uranus is opposite to where it was at your birth. This happens between the age of thirty-eight and forty-four. The third transition is a relatively recent innovation, as astrologers did not know of Chiron until 1977. An individual reaches their Chiron Return around the age of fifty when the planetoid Chiron returns to the position it was at your birth. These transitions are major stages in astrological terms. According to astrology, a person does not even begin to understand their purpose for existence until their Uranus Opposition. However, until the twentieth century, only a small amount of the population lived above forty years of age. It is because of the extended longevity of the Baby-Boomers that this is the Fullness of Time. We do not believe that the generation that spawned the hippie movement has completely forgotten the feeling

of being able to achieve anything, because of your maturity, now you can. It is time to step forward again.

It is interesting when considering the millions of people born between 1945 and 1983 that the Body of Christ consists of just 777,000 people. (Again not limited to Christians per say) This is only a very small percentage of the population. It is mind-boggling to think that we need just a mere 777,000 people to become compassionate, for the world to transform, but that is because of the power of selfless love. More than two billion people were born during this time (2,213,012,000) Even if we halve the number, (1,106,506,000) allowing for early deaths, there are still more than one billion potential members of the Body of Christ. The number 777,000 is less than one percent (0.7030%), so why so small a percentage? The answer is because of the seduction of the world many souls buy into the illusion and never remember why they were born.

Craig and I asked God "Are only people born between 1945 and 1983 involved in assisting the spiritual evolution?" Apparently, it concerns the age of spiritual decision. Consequently, everyone on Earth who is over the age of twenty-one has to choose whether to be a part of the problem or a part of the solution. Children, irrespective of them being old souls are subject to their parents. With that said, there are exceptional children on the planet today, who chose to incarnate at this time. Parents of these children, can help by being an example to them. We must always remember that although the soul of the child may be old and wise, it is still in the mind and body of a child. Therefore, as with all children, he or she needs guiding through discipline and clear boundaries.

Jesus said he would return at the Fullness of Time. Reviewing our experience and teaching, Craig and I feel the goal of his return was to speed up the spiritualization of matter. When Jesus reappears, he will do this in a very public arena, where there are television cameras. This is what he meant when he said, the son of man will appear, like lightning flashes

from the east to the west. Remember there was no satellite TV in the first century.

It is up to each individual. No one can do it for anyone, he or she must decide for his or herself. The question is, if he or she believes anyone can change the way he or she thinks and become selfless. The alternative, is to believe that every human being is hopelessly selfish. Craig and I believe in the former. Given the chance, we believe that most people will rise to the occasion, the question to ask yourself is, will you? J.F.K said in one of his most famous speeches, "Ask not what your country can do for you, ask what you can do for your country." Craig and I would go one step further and say, ask not what the world can do for you; ask what you can do for the world.



## : - GREAT NEWS UPDATE - :

In our original book *THE GOOD NEWS: An Alternate Theory*, I wrote that between 2004 and 2005 the start of a five-year window would begin. To recap: "What that means is during this time, the human race will fight the metaphorical battle of Armageddon within their mind, using their heart for spiritual discernment. Because this is the Fullness of Time, the astral plane is dissipating and the three levels are condensing into one. Because of this, all spiritual forces within the astral plane that have assisted humanity, such as angels and guardian spirits, have been asked to release all contact with their charges in order to let us do the work ourselves."

"Unfortunately, Humanity does not escape all outside influence. As stated, every thought and emotion is energy and permeates the ethereal or Astral Plane. Every spiritual entity in the Astral Plane that does not have Humanity's best interests at heart has lost individuality. Now, all lower spiritual forms have merged into one all-consuming power, which we will call the World Soul, although Animal Soul would be more appropriate. *The Emerald Tables of Thoth the Atlantean*, translated by Doreal, relate that there are mythical beasts, which the tablets call the "Hounds of the Barrier," guarding the exit out of this cycle. According to the tablets, only those of the brightest light are able to pass by the hounds. We believe that this is an analogy of the World/Animal Soul. If we remember that in both cases the barrier used is of an

animal nature, we can begin to see the role these figures play. Animals are territorial. As such, all animals will defend their territory with their lives. Human beings reflect this behavior by dividing the Earth into different countries, which they feel obligated through patriotic fervor to defend."

"It is interesting that although the goal of evolution is to drive the Life principle to individualization and self-awareness, the objective of involution, or the redemption of the Divine sparks is the reverse. Consequently, only those individuals who no longer see themselves as separate from every other soul will pass by the guard through the door. In other words, it is necessary to view ourselves as above all differences, citizens of the planet Earth.

Both the World/Animal Soul and the Hounds of the Barrier are of the same vibration as the aggressive masculine energy that we see in the Human Race through the lower ego's passions. Despite the designation masculine, this energy is not exclusive to men. Women who demonstrate anger, jealousy and ambition or any of the passions connected to the lower ego are exhibiting the same "masculine" energy. Because the World/Animal Soul and Hounds are of the same vibration, they can recognize those individuals that have not transmuted the masculine energy. In addition, this vibrational energy relates to the third or solar plexus chakra."

With the disincarnation of Christ Jesus, the scripture in Revelation 12:12 comes into play. "Therefore rejoice, you heavens and you who dwell in them! But woe to the earth and the



sea, because the devil has gone down to you! He is filled with fury, because he knows that his time is short."

Earlier, I wrote: "Jesus' sacrifice had two primary outcomes. First the cleansing of the upper levels of the Soul Plane, which was good. Sadly, as the scripture in Revelation warns, this meant expelling the densest and worst elements of the World Soul and his minions to the lowest levels of the Astral Plane. At this point, the World Soul becomes the *Shadow of Deception* AKA "prince of this world", or Eckhart Tolle's *Collective Pain Body* in a fight for existence with the *Light of Truth*. Still connected to every human being through their subconscious, for nearly two thousand years this entity fed off the depravity of Humanity, by inciting as much atrocity and selfishness as possible.

Although, at the time we wrote the quote from *THE GOOD NEWS: An Alternate Theory* it was an accurate statement, as was the statement above from earlier in this book citing the *Shadow of Deception's* actions for nearly two thousand years. However, the future is never locked in stone.

As a result, our actions can change the course of history at any time. Therefore, the really *Good News* that should *Reverberate* throughout the world is that none of the above applies now. This is because the Divine forces neutralized the *Shadow of Deception* in 2010. We explain this in our recent book *FOR THE CHILDREN*; consequently, we will reprint the relevant excerpts below:

### ***END TO WICKEDNESS IN HIGH PLACES***

*Throughout this book, we have referred to the neutralization of the Shadow in 2010. Considering the state of the world today, we would expect many to be skeptical at such a claim. Nonetheless, it is true. We thought long and hard about relating the details of our experience concerning that time, as it challenged everything we understood about physical reality. Still, this book is about truth, and the truth of our journeys and this experience affected not only our spiritual evolution, but also the world.*

*Our trip into the twilight zone began with discovering the Orders of the Quest and the Light's plan for America. Earlier, we mentioned that David Ovason related in his book *The Secret Architecture of Our Nation's Capital...* how the Founding Fathers set the energy for America. To recap: aligning the Federal Triangle comprising of the White House, the Capitol, and the Washington Monument with 3 major stars, the Founding Fathers' goal was to have the US guided by the Light.*

*As a Brit, I had been baffled as to why America had two separate areas named Washington. Most foreigners upon hearing we live in Washington assume this means the Capital on the Atlantic Coast, instead of nearly 3,000 miles away in the Northwest on the Pacific Coast. After learning of the Federal Triangle, I had wondered if there was any connection between the two*

*Washingtons. There was, and learning how they were connected catapulted us into a completely new way of thinking about energy and evolution.*

*In May 2010, I was working on the final sections of part 2 of my thesis. As stated, during this time we were reading David Ovason's book. Shortly after finishing his book, we had a revelation that the energy had shifted from the nation's capital to Washington State, but at first, we had no idea how. We record the sequence of events that led to our understanding in Section 13 – 1994 to 1997 of the above-mentioned thesis in Stage Cycles and the Ancient Wisdom for Now Page:*

*"On first learning the "Light" had shifted the energy and consciousness of its plan for America to Washington State, I had wondered why. To me the logical move would have been to move north to the original landing site of the Puritans. But, the simple answer is that the northeast of the US did not contain a way to reflect the Mystery of Washington D.C... While talking about my dilemma as to the connection between Washington D.C, and Mt. Rainier to our dear friend and co-director Guy, he mentioned the popular legend of the three mountains Mt. Rainier, Mt. Saint Helens and Mt. Hood forming a triangle. This made me think of the importance of the triangle formed by the Capitol Building, the White House and the Washington Monument. However, when I looked at a map, the triangle formed by these three mountains did not match the triangle formed in D.C., furthermore, Mt. Hood was not in the State of Washington.*

*"Visualizing the D.C triangle, I knew that one of the points needed to be at least twice the distance from the other two points. I suspected that Mt. Rainer and Mt. St. Helens were two points of the triangle, but I could not find the third; that is until I remembered that the Cascades are not the only Mountain Range in Washington, there are also the Olympic Range of Mountains. Moving my search to the Olympic Mountains, I almost fell off my chair. There in the range was Mount Olympus named after its Greek counterpart, which was in Greek Mythology the "Home of the gods." Drawing a line between all three mountains, an almost identical triangle to the one in D.C appeared.*

*"The most amazing thing was that the three mountains in Washington State matched up to the three buildings in Washington D.C. In aligning both triangles with one another, the tallest Mountain, Mt. Rainier aligned with the tallest building the Washington Monument, the next highest mountain, Mt. Olympus aligned with the Capitol and the lowest mountain, Mt. St. Helens aligned with the White House. If this wasn't enough the line connecting Mt. Rainier, which represents the star Spica in Virgo, with Mt. Olympus passes directly through the site for the Know Thyself Initiative.*

*"Feeling that it would be important to show what I had discovered, I asked Craig to overlay two triangles for the maps I found from MapQuest side-by-side. During the process, we were given an amazing gift, but first let me share with you the process used. Having seen the possible connection in my atlas, on the MapQuest website, I typed in 1600 Pennsylvania Ave to get a map of the Federal Triangle. Zooming out to the scale of 1200 feet per inch, I printed out the map. Then I typed in the location for the Know Thyself Initiative in Washington State and again zoomed out until I could see all three mountains. The scale was 18 miles per inch, which was 79.20 times the scale of the Federal Triangle. Giving Craig the maps, as they were not in color, he reprinted them and then scanned them. I will let Craig explain what happened next. "Both maps were then imported into my graphics program. Over the Washington D. C. map I drew a triangle connecting the 3 points of interest. I cloned (copied) that triangle and placed it on the Washington State map and repositioned that exact triangle to cover the 4 points of interest. To my amazement that exact triangle, after moving and rotating on the map, covered the 4 points without any changes to the triangle other than the position." Both of us wonder about the odds of the exact same triangle for the Federal Triangle in Washington D.C fitting a different scale map of three mountains in the state named for the former."*

*While I was writing the above in the spring of 2010, our guidance moved me to contact Joy, the woman who had literally saved my life in 2002. As I was experiencing considerable discomfort, I thought it was to get Joy to shed some light on it, perhaps even heal me. Still, there was an even more important reason.*

At that time, Joy and I were estranged. Without going into the whys and wherefores, our friendship broke during a particularly confusing time for both Joy and us. Following an especially distressing instance in 2008, Joy stopped seeing us altogether. The inspiration to contact her made me hopeful of the possibility of rekindling our special relationship. In spite of being apart, I always felt connected to her. After all, this woman had saved my life.

Demonstrating her magnanimous spirit, upon hearing of my discomfort Joy graciously agreed to give me a treatment. Thus, Guy arranged an appointment for me at the end of May. Believing that the motivation for seeing Joy was to reconcile, as well as have her help me, I nervously walked into her office with Craig and Guy.

Unfortunately, once in her office we quickly discovered reconciliation was the furthest thing from Joy's mind. Making sure that we knew her intentions, our friend informed us she wanted nothing more to do with the Foundation, or us. Her recalcitrance devastated me and distressed I began to cry. Looking to both Craig and Guy for support, I met stunned confused faces. Nevertheless, Joy was the consummate professional. Therefore, attempting to ease the tension she asked me if I still wanted a treatment. Unsure why, as I was extremely upset and all I wanted to do was get out of there, bewildered I mumbled "yes" and stood up.

Directing me to the table in the middle of the room, as I climbed onto it Joy instructed me to lie on my stomach. Exceedingly grateful, as lying face down meant I could bury my head in the pillow I laid down. Laying there the only thing I remember is feeling my heart was breaking apart.

Although I was sobbing, I could hear Joy moving around and felt her place a Tibetan bowl on the middle of my back. She worked diligently for more than half an hour while I quietly sobbed into the soft pillow. Tapping me on the shoulder, she smiled at me as I rolled over and sat up and thanked her. As Joy stood behind me massaging my shoulders, I was surprised when she said, "It is the world who should thank you."

Still unsure as to why the Great Spirit-Mind had me experience such sorrow, I tried to process what had happened. However, although I did not experience anything but severe emotional distress, this was not the case for Craig. Throughout our journey Craig has been the one to have the most detailed, explicit and sometimes multidimensional visions during ceremonies or as he likes to call them, "Event Gatherings." Yet, for some unknown

*reason after starting the Know Thyself Initiative, the visions had subsided. Craig admits that even though this was not disturbing, it was unusual.*

*Craig relates, how while I lay face down on Joy's table, he was trying to wrap his head around the situation. Closing his eyes, immediately he felt swept up in a wondrous vision. Later, when we got home from Joy's office and Guy came over; Craig shared his experience with us:*

*"The whole idea of incorporating Joy into the energy mix of relieving, or at least lessening Suzzan's physical discomfort was a puzzle to me. So clasping my hands around my knees in a sustainable and comfortable position, I put my head down and closed my eyes.*

*"Everything appeared in shades of grey (greyscale) and it seemed as though I was in the eye and at the top of a huge swirling energy funnel. At first, this was odd to me because all previous visions were in vivid color. Clearing my mind, I opened to the flow. Not moving physically, my vantage point moved and the vision took place to the right of me where Suzzan lay on the table.*

*"Observing the energetic movement of an endless greyscale plane, I noticed that sometimes it presented itself in a vertical cross sectional view. Managing to skew horizontally, it showed me another side of its movement. The whole thing was alive to me, as if the vision was a combination of Suzzan mixed with the universe in an energetic way. I observed the energetic mass for some time. Then, suddenly there was separation and I could see two vertical cross sectional views formed one above another. Appearing calmer, the lower plane was also lighter than the one above it. Once again, horizontally skewing the view I saw that the plane above was finite in size above the infinite lighter plane below. Yet neither plane was connected as I witnessed by my changing view perspectives. Following this pattern for a while, suddenly the vision shifted to a visual perspective above the lower, lighter plane just inside some hazy translucent mass. This view only lasted long enough to see a finite dark mass extend a thread down into the energy plane below it and reduce in size as if to empty itself in the lighter plane below. Even so, the mingling of these planes did not cause the lower lighter plane to combine with it and darken*

*in color at first. Nevertheless, as I watched a distinctive black network of lines did eventually permeate the lower plane.*

*“From my perspective above the lower plane, I observed the former calm plane appear to become agitated with sporadic bursts of dark and light energy balls of various shades of grey. The distinctive networked lines were no longer visible to me. Watching the darkening plane below for a good while, it seemed to get more unsettled and distant from me the longer I watched. Even though it was all I could see below me, I could tell I was moving away from it. I saw and felt the lack of calm below me. Suddenly at a great distance away a burst of yellow-orange lightning shot through the plane shattering into many smaller lightning bolts creating a large area of light and revealing the great depth of that below me. I was quickly transported to my original energy funnel as I watched what appeared to be thick black lines or beams fall down the sides of the vortex funnel.”*

*It would be many months before we understood what the vision meant. First, there was to be another bizarre ceremony of sorts, this time orchestrated by Craig. This one began at the end of June, when he described how he planned to create a visual expression of the two triangles representing the Federal Triangle and the three Washington Mountains, related earlier. His plan was to unite both triangles over a picture of a tree signifying the Tree of Life on our web site. As the triangles represented both Washington D.C and Washington State, it all made a weird kind-of sense.*

*After the treatment with Joy in May, I finished writing part 2 of the thesis, with the understanding that we were to incorporate it into stage Cycles of the Know Thyself Initiative (KTI). While I was finalizing it, Craig designed his new web page. Unlike the other web pages on our site, this page was essentially a tree. Only it was no ordinary tree. Instead, it consisted of different levels put together to create the illusion of a real tree overlaid with the 10 Sephirot representing the Tree of Life. Completing the page by the Summer solstice, he posted it on our site. Then Craig was moved to unite the two Washingtons.*

*Operating from a pure sense of direction, without understanding why, Craig prepared 7 stages to appear over the tree on 7 consecutive days. For some reason, this week was to*

*begin 7 days before my birthday, August 3, 2010. Therefore, July 28 was the first day. Below is a basic breakdown of the different stages:*

- *Day 1: - Triangles from two Washingtons appear above tree*
- *Day 2: - Triangles move together and unite*
- *Day 3: - Rectangle becomes feed horn*
- *Day 4: - Spiral or vortex forms in center of feed horn*
- *Day 5: - Sun appears within vortex*
- *Day 6: - Dove appears in front of Sun*
- *Day 7: - Vortex expands and Dove alights on tree*

*Eventually, the visual expression of the 7 phases became a video, using Adobe Flash software. In the video, Craig created the illusion of moving through our Solar System as well as time, to this event. After bringing us to our modern time, the video depicts the two triangles with their respective partners; i.e., the Washington Monument with Mount Rainier. Then it connects the two Washingtons with each other through the glyph for Cancer with the circles of the 6 and 9 ☿ encircling both Washingtons perfectly over the map of the US. It was through understanding how all this connected that we learned what happened, but we are jumping ahead. First, let us recount the events.*

*All was well until Day 2 when Craig brought the two triangles together. At that time, I developed a severe headache, which lasted all through Day 3 as the feed horn materialized within the enlarged rectangle. Finally, on Day 4, as the spiral or vortex formed in the center of the feed horn, my headache subsided. If like me, you have no idea what a feed horn is, Craig explained it as being like a dish of a satellite that feeds signals to the world.*

*We see what kind-of signals the feed horn is feeding the world in Days 5 and 6, when a graphic of the Sun representing the Light of Truth emerges from the spiral, or vortex (5), and then a White Dove of Peace materializes (6) in front of the Sun. Finally, on Day 7, the vortex expanded encompassing the top of the tree, which now symbolizes the Earth Plane, and Peace entering our world, signified by the Dove alighting on the tree.*

*The last Day was the most challenging for me, as my headache, which had subsided for two days returned in force. For twenty-four hours I felt as though my head was about to explode. As this was*



*my birthday, Craig postponed any celebrations until the next day. To be honest, neither of us had any idea as to why Craig was moved to put this on our web site and as I recovered quickly, we basically put it out of our minds; that is until about a week before the Autumnal Equinox. It was during this time that an interesting phenomenon we had discovered about our home would come into play.*

*Throughout the 5 years we owned the 7 Keys Center, we would conduct meditations for Peace on the spiritual nexuses of the year. These points of the year have been marked since ancient times; we know them as the spring and autumnal equinoxes and the summer and winter solstices. In 2005 with the center no longer available, we switched the venue to our home. Initially we thought this was from expediency; however, we soon discovered it was because there was some type of energy vortex in our living room.*

*Due to both the spring and autumnal equinoxes being auspicious times to focus on peace and harmony, we always set time aside to meditate and pray for peace and healing in the world. Seeking guidance on what kind-of ceremony to perform that year, 2010, I was given that I alone needed to perform a ceremony September 22, starting at 3:00 pm for 33 minutes. As by this time we were used to strange requests, neither Craig nor I were concerned.*

*Thinking I was going to meditate/pray for peace by standing, sitting or kneeling in the vortex, I was a little disconcerted when Craig hauled a large granite rock up to our house. My level of confusion rose even higher when he matter-of-factly informed me we were to use it in the equinox ceremony. Looking like an egg cut in half, it was not exactly what I had envisioned sitting on. Still, after meditating/praying I learned that this was exactly what was required of me. The instructions were very detailed. I was to sit on the rock with only a folded thin Islamic scarf for a cushion. More importantly, I was to divide the 33 minutes into three segments of 11 minutes each, changing positions each time.*

*All through my life, I have had to sit on some uncomfortable seats, but the time spent sitting on that granite rock was the longest 33 minutes of my life. Desperately, trying to take my mind off the pain, which was considerable, I begged Craig to talk to me, which he did. This was the strangest aspect of the whole thing. To me it was necessary for me to focus on peace and harmony to be*

*effective, but instead all I could think about was concentrating on holding each painful position.*

*At last, the clock reached 3:33 pm and I was able to get off the rock. Barely able to stand, I was at a loss as to the purpose of the ceremony and did not gain any clarity until later that night. Yet even then, the reason sounded so preposterous that neither of us could believe it.*

*Apparently, that ridiculous ceremony was the third and last of three, which began earlier that May in Joy's office. I am sure we do not need to tell you that Craig's connecting the two Washingtons above a representation of the Tree of Life over 7 days in late July and early August was the second.*

*Amazingly, we learned the Light used my body to end spiritual evil, even as I squirmed on the rock. What is more, both of the previous adjustments were to prepare my body energetically to act as a vessel of purification. In asking what it was, I was purifying, I heard, "The Shadow." Forget that we are talking about a spiritual consciousness connected to every human being through the pain-body. Not only did our guidance ask us to believe that the ceremony severed the link between the individual and the Shadow, but we were supposed to believe it also purified the entire Soul Plane. How could this be? The answer turned out to have several levels concerning a Divine Plan straddling many millennia.*

*We mentioned earlier that it is impossible for the human brain to comprehend how spiritual forces operate. We can only identify with spiritual operation by relating to concepts we do comprehend. What occurred in 2010 was a perfect example of this. To understand, we had to stop interpreting the events from our conventional understanding. Instead, we had to see ourselves as energy consciousness. Even more important was the need to recognize that as with my experience in Jerusalem, Mexico, and South America, not to mention the tumor/entity in 2002, the Light could use my body without my knowledge or volition.*

*Again, we must emphasize this has absolutely nothing to do with me being anything special, it is purely an energy signature within me that can apparently be utilized. With that said, we will explain how the Light revealed this event to us. Not surprisingly, as we said, initially the information was impossible to believe. However, later that night I noticed something had changed. As I mentioned since childhood I was afraid of the dark. Although, I*

*never saw anything, I always felt something ominous was somehow hiding in it. That night it was gone and there was nothing but soft darkness. Again, we fully expect that many will be skeptical at such a claim and of course, with no evidence, most people will dismiss it as delusional. Be that as it may, the reason we are sticking our necks out, so to speak, is what it means to the Human Race's spiritual development.*

*We cannot stress too strongly, how important it is to remember not to envision the Shadow as an individualized consciousness, like the devil or Satan. Even if at times, it would appear to operate in that way. Rather we should see the Shadow as representing a kind-of collective thought or accumulation of the strongest wills (egos/pain-bodies). This consciousness was literally nothing more than a construct of our thoughts and emotions. With its neutralization in 2010, we cannot only transform ourselves, but also the world. If this sounds too, pie in the sky, let us share with you why we can make such a statement. Our understanding came from investigating the meaning of the events during those months.*

*Obviously, the video and 7-day ceremony originated from reading David Ovason's book. It literally acted as a trigger to launch us into a new level in thinking. Most of what we discovered is in the aforementioned part 2 of the thesis entitled Fullness of Time: the Mysteries Uncloaked Globe D on our web site. Yet, as it is critical to not only understanding Carol's and our journeys, but also the future of the world, we will encapsulate the relevant parts to explain the process.*

*One thing puzzled me about the Federal Triangle. It concerned the type of structure chosen by the Founding Fathers for one of the buildings. My investigation into how the Light and the Shadow influenced humans en masse in the past revealed the primary way was through structure. For instance, the Light used beautiful architecture in the Gothic cathedrals to conceal the Mysteries. Perhaps not surprisingly the Shadow's preferences were more masculine i.e., the phallus in the form of obelisks. With this clear distinction, my question was "If obelisks represented the Shadow then why use one in the Federal Triangle?"*

*Contemplating the perplexing problem, I remembered writing in the thesis of how Gian Bernini transmuted the energy of obelisks in Rome through manipulating the elements, or emotions. Suddenly the light went on and I understood the Founders reasoning. By aligning the obelisk of the Washington Monument with the powerful*

star Spica, representing the Divine Feminine and the Universal Christ, they created the perfect union of balance and harmony. In other words, the Founders usurped a tool of the Shadow to benefit Humanity.

Another connection of Washington D.C. to Washington State is uncovered through the sign of Cancer. David Ovason relates hermeticists viewed Cancer as representing "a sort of gateway between higher and lower worlds." This point reveals the Founders and the Light always intended Washington State's connection to the nation's capital. Mirroring the skies on the ground by placing 3 key buildings in exact alignment with 3 stars to form the Federal Triangle, America's Founders symbolized the axiom As, above, so Below, or the Microcosm (ground) mirroring the Macrocosm (sky). Add to this the 3 mountains of Washington State exactly reflecting the Federal Triangle, and a third component is brought in; only this one is natural not man-made. This third component involved uncovering the secret of an ancient relic, which revealed an ancient plan to bring the Macrocosm and Microcosm together at a specific site.

So far, we have answered why the Founding Fathers used an obelisk in the Federal Triangle. Put plainly, they planned to transmute the energy of the Shadow through aligning its primary symbol with a powerful star representing the balance between masculine and feminine. Yet, there are still some puzzling actions by the Founders in respect to setting the energy and spirituality of the New World. This is because they appeared to associate America with the Roman Empire.

Logically it makes sense that the Founders would want America to reflect strength. There is no doubt that as the Romans conquered Greece and took over the Hellenistic Era they were a very strong empire. Nevertheless, the Romans spirituality was not as strong as their Greek counterparts. We see this in the fact that the Ancient Mysteries originated from Greece, not Rome. So why would the Founders, who were also members of the Orders of the Quest infuse the country with a less spiritual connection? The answer is they did not.

It was necessary for the Founders of America to include the Roman influence because of a sacred Greek relic that the Romans inherited known as the Palladium. Considered to be the supreme treasure of the ancient world, according to Mr. Ovason it was the "image of Minerva" and believed to be connected to "one of the

*greatest esoteric Mysteries of the ancient world.” Such a powerful proclamation indicated to me that the Palladium warranted further investigation.*

*Researching the Palladium, the first thing that struck me was its Greek origin. This made me wonder why the Founding Fathers had not used images of Athena instead of Minerva in their imagery. I discovered the answer lay in the history of this sacred relic. Historians believe it was a wooden image of Pallas (whom the Greeks identified with Pallas-Athena and the Romans with Minerva). Purportedly the image fell to Earth in answer to the prayer of the founder of the ancient city of Troy.*

*I found this amazing, as with Brad Pitt’s portrayal of Achilles in the 2004 movie Troy, we all know what happened to the Trojans. It seems the legend reports that after the Greeks discovered the Palladium was protecting the city of Troy; Odysseus Diomedes stole it with the help of Helen of Troy before using the famous Trojan Horse ploy to enter and conquer the city. Afterwards, the exact whereabouts of the Palladium is unknown, because there are two possible destinations. The most logical is that the victorious Greeks took their prize back to Athens the city of Athena. However, there are several legends that say the Palladium ended up in Italy. One legend says it was “kept there in the temple of Vesta in the Roman Forum.” This in itself would be surprising, as at the time of the Fall of Troy, Rome had not emerged as a republic. Although no one can be certain, legend has it that Rome would not become a reality until nearly 500 years after the sacking of Troy.*

*Regardless of this, as the Romans conquered the entire region and took over from the Greeks, they could well have acquired the Palladium from them. Furthermore, as it was such a priceless relic of one of their prime goddesses, it made sense that they would take it back to Rome with them, especially because of the belief the relic protected the city that housed it.*

*With the fall of Rome, either the efficacy of the Palladium would be in doubt, or it was no longer there. This brings us to another legend that suggested Constantine took the relic to Constantinople, modern day Istanbul. After occupation by the Ottomans, the Palladium vanished from both the city and history. Bearing in mind that it was wooden it is no surprise that the Palladium disappeared. After all, wood is organic and will eventually rot. Nonetheless, Mr. Ovason relates that “some esoteric scholars” assert that it was “not lost, but hidden away in another country.” Interestingly, this*

country would be "where the civilization of the future was to develop."

The above statement is the key because as Mr. Ovason informs us, the Palladium would be needed, not to protect a city, but for its primary function; namely, to "act as a spiritual center for the dissemination of that esoteric lore," in other words—The Mysteries.

It is important to keep in mind that both goddesses Minerva and Pallas-Athena were goddesses of wisdom and that they were associated to the Egyptian goddess Isis. In this respect, the most important information Mr. Ovason provided about the Palladium's purpose was his association with it as a "torch" that was "passed on from a dying civilization to an embryonic civilization by the Secret Schools."

With the three mountains of Washington State reflecting the Federal Triangle, we can see how the relic's influence could be present in America. With the location of the Know Thyself Initiative falling on the line between Mount Rainier and Mount Olympus, it is even more possible that the Founders specifically transferred the Mystery of D.C. to the City of Destiny, otherwise known as Tacoma.

As the Palladium was originally Greek, obviously the natural connection was the oldest and therefore the purest. Accepting that the Federal Triangle in Washington D.C. represents the Microcosm and the three stars represent the Macrocosm, then the three mountains would be the bridge between the two. Could the location for the site of the Know Thyself Initiative (KTI) within this powerful nexus indicate that the image of the sacred relic of the Palladium has become the energy and consciousness of Wisdom acting as the third component, a bridge between the Macrocosm and Microcosm? If so, we believe the Founding Fathers always intended Washington State to connect to Washington D.C., to reveal The Mysteries. Moreover, by having the obelisk, or the Monument in D.C. reflect Mt. Rainier, the closest mountain to the site of the Know Thyself Initiative, the energy connection is even greater. KTI representing the bridge between the Macrocosm and the Microcosm is epitomized by its existence in the mass consciousness (web) or Mind-Stuff between spirit and matter. Naturally, the growing number of esoteric schools on the web, which connect to the energy, strengthens this.

*Although there appeared to be a possibility that our whole experience was preordained centuries, if not millennia ago and that everything had a purpose, I still struggled with my role. "How could an ordinary person facilitate something so huge?" As with our experience in Jerusalem, where we came to understand the Light used my body as a kind-of doorway. We learned it was a similar situation that September afternoon in 2010, with the Shadow's neutralization, only as stated; it started in Joy's office at the end of May.*

Obviously, the 33 minutes divided into 3 eleven-minute increments foreshadowed the 11-11-11 global event to promote peace on November 11 2011. However, what Craig and I did not know at the time was that Humanity sowed the seeds of the event years earlier. They did this with the mass awakening of millions through Oprah Winfrey's collaboration with Eckhart Tolle in the web series of spiritual teaching around his book *A New Earth*.

Something else that also triggered the shift was in the election of Barack Obama. Please understand that this is not a political endorsement of our president, but rather recognition of a shift in consciousness. By this, we mean electing an African American to such a position demonstrated a massive shift from prejudice and bigotry to one of tolerance and acceptance.

Irrespective of his achievements, Obama's election had serious consequences to our overall evolution. We must say that many other individual actions added to the impetus, but these were the two primary reasons. As such, we could end our book *FOR THE CHILDREN* with the section:

### ***HOPE FOR US ALL***

*If the above discussion on the Mysteries sounds too convoluted and mysterious, then let us reassure you that it is perfectly okay. We each have a role to play in evolution and each role is different. Think of it like this, we cannot all play professional sports, or be professional musicians. Most of us will also never be famous actors or invent some groundbreaking creation that changes the world. However, we will all participate in these individuals' achievements; simply by buying tickets to games and movies and purchasing the inventions. As a result, although many will apply the teachings above, it is not necessary for everyone to do so. Yet, ALL can participate.*

*By becoming conscious human beings, we change not only the way we think, but also our vibration and frequency. Carol reported that the ETs, or as she calls them the cosmic cultures stressed the need to access a new frequency, but what exactly does that mean? How do we access a different frequency and for that matter why would we? To understand the reason the ETs urge us to adopt a different frequency is because it opens us up to all kinds of possibilities. Moreover, it is our evolutionary destiny.*

*In the Forbidden Fruit section of Chapter 7, we mentioned that part of the problem of the Fall was altering the consciousness of the humans from the Theta level to the Alpha level. We utilized the article Schumann's Resonances and Human Psychobiology written by Richard Allan and Iona Miller. To recap: In Theta (4-7 Hz), the senses are withdrawn from the external world. Instead, they are focused on the mindscape, internally originating signals. Theta waves are associated with mystery, an elusive and extraordinary*



realm a person can explore... they are receptive to information beyond their normal conscious awareness. In addition, investigators have also identified Theta as the gateway to learning and memory. In that, Theta waves awaken intuition and other extrasensory perception skills.

On the other hand, as stated the Millers viewed Alpha waves (7.8-13 Hz) as present during dreaming and light meditation. As the majority of "neurons" adapt to the Alpha wavelength, alpha waves rotate over the entire brain. Again, the Millers believe that it is during the Alpha wavelength that people tap into their "creativity," which resides immediately beneath the waking consciousness. They state that the alpha wavelength is the "gateway" or "entry point" to "deeper states of consciousness."

Amazingly, it is the Millers belief that the Alpha wavelength is "the home of the window frequency known as the Schumann Resonance" that provides the key to why the ETs encourage us to adopt the Love Frequency. In respect to this, even more relevant is our growing connection to the inner earth, which I was unaware of until working with Dr. Calleman on his new book. For us the importance of his book is revealing that the inner Earth layers may very well be at higher frequencies than that of the Schumann Resonance.

There has been a lot of talk about the shift in frequency, particularly the belief that the Schumann Resonance is rising to 13 Hz. Originally the theory of the rise in the Schumann Resonance rang true for us, as is demonstrated in our writings, and we were in accordance with it. However, after reviewing the actual reason conventional science dismisses the theory, we were not so sure. As none of us are scientists we are unqualified to judge, but like so many, we felt like the vibration of the earth was rising. Considering that everything is essentially vibrating conscious energy we could not ignore the overwhelming feeling of the Earth's vibration rising. Yet after working with Dr. Calleman, who also dismisses the theory of the Schumann Resonance rising to 13 Hz, we discovered the possibility that both sides may be correct. How can this be?

As we mentioned earlier, the title for Dr. Calleman's book is *THE GLOBAL MIND AND THE RISE OF CIVILIZATION: A Novel Theory of Our Origins*, and is the first volume in the trilogy *The Paradigm Shift*. In this book, Dr. Calleman not only shows why he disputes the claim that the Schumann Resonance is changing. We think it could also provide the reason why so many feel the base

*frequency of the world is rising. Although we must say this is our interpretation, not his. To us the book strongly indicates that we are shifting our focus from outside to inside. Of course, as is evident in our writings, we already believed this. Still, it is interesting to see this confirmed through a graphic showing the inner layers of the Earth. This graphic reveals that the closer to the core we get, the higher the frequency. What really jumped out at us was the outer core is at 13Hz!*

*Remembering the Schumann Resonance is the cavity between the surface of the Earth and the Ionosphere, the inner earth layers would not be a part of this cavity. Remarkably, this is how we can consider both sides of the argument correct. The scientists stating that the cavity making up the Schumann Resonance is not changing are correct. However, as so many awakened individuals feel drawn to the inner kingdom, their sense that the Earth's frequency is rising is also valid. Only it is not the frequency in the cavity they are feeling/sensing, but rather the vibration from inside the earth deep below the surface. Revealing this new understanding uncovers the importance of adopting the Love Frequency.*

*The Love Frequency is at 13 Hz, which is why Gregg Braden and others have advocated that Humanity is moving towards it. Only as we said it has nothing to do with the Schumann Resonance. We realize that this flies in the face of Braden's teachings, but bear with us a moment because we hold the greatest respect for his contribution to our understanding. If we remember, the angels exposed the early humans to the Astral Plane before they were ready. At that time, they were operating at the Theta (4-7 Hz) level, which made them much more spiritual. Afterwards they switched to the Alpha (7.8-13 Hz) level. Since this level connected to the Astral Plane, it resulted in their unfettered thoughts and emotions escaping into that plane. As we said, this had several adverse consequences; most obvious was creating an imbalance between the masculine and feminine principles. However, what we did not know until recently was that the Shadow of Deception operated within the Schumann Resonance cavity, which affected the mass consciousness.*

*In our writings, we speculated that the ETs traveled through the Astral Plane, which is why they can appear and disappear at will. This was the main reason we made the error of deducing that as they moved through the Astral Plane it corrupted some of them,*

causing them to align with the Shadow. However, having determined their nature is unchanged, we realized that they must have a unique makeup that allowed them to move through the domain of the Shadow and remain untainted. They did. Moving through the Astral Plane did not taint the ETs because of their attunement to the Love Frequency.

By operating, or if you prefer vibrating, at a higher frequency outside, or rather inside the Schumann Resonance cavity they were able to remain wholly unaffected by our thoughts and emotions permeating the Astral Plane. They are advising us to adopt the higher Love Frequency, because the ego and pain-body use the lower frequency of 7.8 Hz. Consequently, by rising to the Love Frequency the ego and pain-body lose control over us.

One of the main reasons the ETs have not landed on the White House lawn is because of their frequency; the Love Frequency makes them powerless to defend themselves. This is not because of an inability to. There is ample evidence of the ETs ability to disarm weapons. It is because their frequency makes them incapable of physical violence. Therefore should they be physically confronted by military personnel attempting to detain them, they would be helpless. We realize that this is in direct contradiction to the consensus of opinion. Most people tend to think that such an extremely advanced species would be able to swat us like a fly. However, because they have evolved past the animalistic nature that the Human Race still struggles with, violence of any kind, even in defense, is an anathema to them.

Evolved beings are pacifists, which is why the ETs offer advice to a select few. Even then, when the Shadow was in play, some of the contactees became a problem. Muddying the waters of the ET agenda, some contactees' pain-bodies created memories of a truly terrifying experience. Nonetheless, enough people like Carol were able to receive their message of Peace and it has entered the mass consciousness. Carol told us that like the Star Trek Prime Directive, the cosmic cultures would never interfere with the Human Race's development. This fact did not surprise us, as there is a universal directive never to usurp free will. Then of course, there is the point that the cosmic cultures were tasked with watching us.

For that reason, until we show them we will not respond with violence, they will remain observers. Nevertheless, because the Fall was not the fault of the Human Race, from time to time they have tried to help us. The truth is they care deeply for us and hope when

*enough people hear the wisdom of their message; the Human Race will adopt the Frequency of Love. Ironically, the cosmic cultures represent our evolution into the Frequency of Love, where we too will be incapable of violence of any kind.*

*In the Frequency of Love, everyone has evolved past all concept of separateness. Hate, prejudice, envy, jealousy, and cruelty are concepts of the past. Compassion and Understanding dominates our consciousness. There is no such thing as selfishness or self-interest because although we understand we are individuals, we also know we are each a part of a whole that is interconnected.*

*In short, when we correct the Fall by integrating the ego and dissolving the pain-body, we align with the Divine Will. Then as stewards of the Earth, we recognize our role in working together to ensure that we preserve our planet for our children. Joining our brothers and sisters of the universe again, we gain access to all the cosmic culture's technology amassed over several millennia. As a result, we will restore our beautiful Garden-Water planet to its full glory. For instance, I was recently given that our cosmic brothers and sisters could return our atmosphere to the condition it was before the Industrial Revolution, at the push of a button so to speak. They can also remove all toxic waste and pollution, which would open up many acres of land for cultivation. Is this not what everyone wants?*

*All we have to do is know the Spirit or spirit-mind within us, and stop looking outside for answers. When we do this, we understand our connectedness and no longer focusing on the self, we rise to the Love Frequency of 13 Hz. Every decision and action will then reflect this new understanding in that we will consider what is best for everybody.*

*Despite knowing the teaching of our connectedness through the mass consciousness, we were delighted in finding real scientific evidence that explains the connection. Apart from demonstrating how the inner layers of the earth are at a higher frequency to the Schumann Resonance, Dr. Calleman has a lot more to teach us. Previously I mentioned that his book explained how we could tap into events of the past. Nonetheless, the true value of Dr. Calleman's book is in showing not only our connection to a Global Mind, but revealing how we can use this knowledge of the Plan to awaken and come together in unity consciousness. Moreover, he also provides possible explanations for certain mental disorders, such as Schizophrenia and Alzheimer's, as well as explains why*

people of the East think in holistic terms, whereas we in the West we are more detail oriented.

There is one more argument leveled against the world's ability to transform that we must address, the argument that the evil people in the world will never change. Consequently, if we do not fight against them, they will overcome everyone. This argument brings us back to our question of what Jesus meant when he said, "resist not evil." Was he saying we should ignore evil acts? One of the most powerful sayings that have stuck with me over the years is, the only thing "evil" needs to thrive, is for good men to do nothing. Obviously then we cannot ignore evil, so what was Jesus saying? The answer lies in understanding the nature of reality.

In this world, our reality consists of multiple levels of consciousness. All of which are at various stages of evolution. Forgetting the first three levels, namely mineral, vegetable, and animal kingdoms, we will only consider our level, the human level of consciousness. Within the human level, there are also many levels of consciousness. The lowest levels are the least evolved, or another term we could use is new souls. We observe this level of consciousness in those individuals who act in the most barbaric way. These people make up what we call the lowest denominator. Meaning, as they are the densest or most solid, they reflect the mass consciousness. Many people think that as the occurrence of heinous acts such as pedophilia, mass murders, and the like has increased, it denotes we are devolving rather than advancing. However, this is one of those lies perpetrated by the Shadow. The reason these acts appear to be increasing is because we are evolving and more people are raising their vibration or frequency.

As more people awaken, they are able to affect the mass consciousness. However, unless they pay attention to how they affect the situation, they can become a part of the problem. Yet there is evidence that many more are becoming conscious human beings, demonstrated in the fact we had very few major calamities at the end of the Mayan Calendar. This was a direct result of enough people focusing on Peace and Harmony. Although now it seems that greedy, power-hungry, ruthless men and women populate the world, it is an illusion. Once all those awakening realize that their thoughts and emotions affect our reality and begin to pay attention, then they will quickly affect the mass consciousness. Which means the lowest denominator will in turn quickly reflect the new understanding.

Whether we are religious, spiritual, agnostic, or even atheists, we can all help in the process. Whereas some people spend their lives in study to gain understanding, others help in a more practical way, such as volunteering.

Despite the Shadow's influence, as stated many people have shown that simple acts of kindness and caring go a long way to changing the world. This brings us to something everyone can do to help, adopt and apply a universal axiom known throughout the world as the Golden Rule. Although, most of us know the Golden Rule from the King James Version of the New Testament, there are in fact ten versions throughout the world:

- **Iranian:** "Do not that to a neighbor which you would take ill from him."
- **Egyptian:** "He sought for others the good he desired for himself. Let him pass it on."
- **Chinese:** "What you would not wish done to yourself, do not unto others."
- **Islamic** (Mohammed): "Let none of you treat his brother in a way he himself would dislike to be treated."
- **Jewish:** "Whatsoever you do not wish your neighbor to do to you, do not unto him. This is the whole law. The rest is a mere exposition of it."
- **Buddhist:** "One should seek for others the happiness one desires for oneself."
- **Hindu:** "The true rule in life is to guard and do by the things of others as they would do by their own."
- **Christian:** "All things whatsoever ye would that men should do to you, do ye even so to them."
- **Roman** (Ancient): "The law imprinted on the hearts of all men is to love the members of society as themselves."
- **Greek:** (Ancient) "Do not that to a neighbor which you would take ill from him."

Put into modern vernacular its directive would be —if you would not like what you are doing done to you, do not do it to others. In this way, everyone can become a part of the solution. It costs nothing and as it supports the true spirit, it makes everyone feel good.
